MINUTES OF THE FIFTY-SEVENTH ANNUAL MEETING OF THE  
MISSIONARY DISTRICT OF HONOLULU  
Monday, February 2nd  
1959

The 57th Annual Convocation of the Missionary District of Honolulu opened with the administration of Holy Communion in St. Andrew's Cathedral at 8:00 A. M., with the Bishop, The Rt. Rev. Harry Sherbourne Kennedy, as Celebrant, assisted by The Very Rev. James Stanley Cox, The Rev. Canon Richard H. Baker, The Ven. Norman R. Alter, and the Rev. Norio Sasaki.

Breakfast followed at St. Peter's Parish Hall, with the Women of St. Peter's and St. Andrew's in charge.

The business meeting of Convocation was held in Tenney Hall. The Bishop presided as President, delivered the Invocation, and called the meeting to order at 9:40 A. M.

The Rev. Canon Wai On Shim was appointed Secretary Pro Tempore, and read the Roll Call of clergy canonically resident in the Missionary District. Roll Call of Lay Delegates was read by The Ven. E. Lani Hanchett.

The President declared a quorum present.

The Ven Norman R. Alter moved that The Rev. Canon Wai On Shim be nominated as Secretary of the 57th Annual Convocation of the Missionary District of Honolulu, and that a white ballot be cast in his favor. Motion was seconded and passed.

Guests of Convocation were introduced by the President.

It was moved by The Ven. Norman R. Alter, that courtesy of the floor be extended to The Rt. Rev. Horace W. B. Donegan, Bishop of New York, The Rev. Lemuel J. Winterbottom, St. John's Church, Yonkers, New York, Chaplain to Bishop Donegan, The Very Rev. John C. Leffler, Dean of St. Mark's Cathedral, Seattle, Washington, and The Rev. Moran M. Weston, Rector of St. Philip's Church, New York. Motion was seconded and passed.

It was moved by The Rev. Canon Paul R. Savanack that messages be sent to the following: The Rt. Rev. and Mrs. S. Harrington Littell, Bishop Retired, the Ven. James Walker, the Rev. Canon William Heffner, The Rev. Charles P. Gilson, and Chaplain Kenneth D. Perkins. The Ven. Norman Alter asked that the name of Mrs. Eliza Spencer be included in this list (Due to ill health Mrs. Spencer was unable to be present, and this would have been her 30th Convocation). Motion was seconded and passed as amended. Mrs. Spencer's granddaughter was present at the meeting, and the President asked her to stand and be welcomed by the Group.

Delegates from the following islands were asked to stand in the order named: Hawaii, Kauai, Maui, Guam and Molokai.

The Rev. Mr. Morrett asked that this document be received. His petition was approved.

The President asked that Delegates of Holy Nativity come forward and be introduced to members of the meeting. These included: Mrs. Stanley Kennedy, Sr, Mr. Herbert Keppeler, Mr. Thomas Waddoups, Mr. James Yim, Mr. Robert Buzzelle; Mr. Tai F. Chong, Alternate Delegates were introduced. The Rev. Richard Aiken, Assistant Vicar was asked to come forward and be introduced. The Bishop and The Rev. Mr. Morrett expressed gratitude for The Rev. Mr. Aiken's help to Holy Nativity in achieving Parish Status, and to the above named Laymen for their untiring and very professional assistance.

The Rev. Mr. Morrett then presented the following Certificate of Erection of the Church of the Holy Nativity Parish:

"WHEREAS, the members of the Church of the Holy Nativity, a duly organized mission in the City of Honolulu, Missionary District of Honolulu, acting by and through their Vicar, Wardens, and members of the Bishop's Committee, have duly made application to me, as the Ecclesiastical Authority of the Missionary District of Honolulu to be constituted a self-supporting Parish; and

"WHEREAS, at a meeting duly called the congregation of the Church of the Holy Nativity and its Priest-in-Charge, Wardens and Members of the Bishop's Committee approved parish status and by resolution acceded to the Constitution and have promised obedience to the Canons, and conformity to the doctrine, discipline and worship of the Church; and

"WHEREAS, due proof has been made to me that the said Mission, upon becoming a Parish, will be able wholly to support a Rector; and

"WHEREAS, I am satisfied that the granting of the aforesaid application will be for the best interests of the said Parish, this Missionary District, and the Church at large.

"NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS: That I, HARRY S. KENNEDY, Bishop of the Missionary District of Honolulu, by virtue of and pursuant to the power and authority vested in me as said Bishop and the Ecclesiastical Authority of said Missionary District, do hereby make and constitute the said CHURCH OF THE HOLY NATIVITY PARISH, with all the rights, privileges and obligations of a duly organized Parish, effective on and as of the date hereof.

"IN WITNESS WHEREOF, I have hereunto set my hand this 31st day of January, 1959.

The Committee further suggested that following the procedures of other years, the President of the Convocation be authorized to name delegates and alternates to the meetings of the Provincial Synod of the Eighth Province.

It was moved, seconded and passed that the nominations be closed, and that nominees be ratified by the delegates and members of Convocation.

It was moved, seconded and passed that the President of Convocation be privileged to name delegates and alternates to the Provincial Synod Meeting.

Fixing the date of Convocation in 1960 was the next item of business. The date of February 14 was suggested. It was moved, seconded and passed that this date be set.

Mr. Arthur G. Smith moved that the Bishop be authorized to change this date in case of necessity. Motion was seconded and passed.

The President introduced the Rt. Rev. Horace W. B. Donegan, Bishop of New York - also, Bishop of the largest Diocese - numerically, - to delegates and guests. Bishop Donegan said it was a joy to come to Hawaii at this particular time and to participate in the Opening Service. He was particularly interested in Bishop Kennedy's comments on "Worship" at the Service. The Bishop of New York commented on the enthusiasm of the congregation in its participation of singing. He heartily approved giving the Annual Address in the framework of the Church. He stated that a great many Dioceses have fewer confirmations than in Honolulu, Hawaii and for this he praised the ministry in this area.

Bishop Donegan has served on National Council as Chairman of the Overseas Department six years, and stated the Home Church is grateful for the leadership in the Church here, and that this area is the "most alive" of all missionary districts. He urged all to support Bishop Kennedy in his efforts to have this Diocese become self-supporting, and that all should unite in raising funds for this purpose.

The Very Rev. John C. Leffler, Dean of St. Mark's Cathedral, Seattle, and Mrs. Leffler were introduced. The Dean came as representative of The Church Divinity School of the Pacific where we have seven men in the Seminary. Dean Leffler brought greetings from these seven seminarians, and from the faculty.

CDSP is now the third largest seminary in the United States with more than 150 students; 112 from the Eighth Province, 7 from the Diocese of Honolulu.

A building campaign is underway. Master planning has been done with the idea of acquiring all property in one block area. Keeping the school running while building is difficult. The master planning is flexible, calling for an expenditure of \$4,000,000; this figure has been determined by qualified architects, and it is hoped between 1959 and 1960 the amount can be raised.

How to raise the money: The school does not intend to assess or "put the bee" on any diocese without consent. The amount programmed for this diocese Honolulu is \$143,000. The first step to be taken locally will be to organize a special gifts committee. Experts will be available to help in this campaign.

The campaign for fund raising is July 1, 1959 to July, 1960. The campaign will be worked on a mutual agreement basis.

The Rev. Paul M. Wheeler made the following resolution: RESOLVED: That this 57th Convocation of the Missionary District of Honolulu give its hearty approval to the forthcoming building campaign of the Church Divinity School of the Pacific with the assurance that all possible effort will be made to assume its full share in the project.

Resolution was seconded by the Rev. Robert Sheeran, and approved.

Dean Cox raised the question about the appointment of a Committee for this, and by agreement during discussion, it was decided that the Bishop would appoint a committee of graduates of CDSP who are interested and would be willing to give time.

It was moved by Mr. Smith, seconded and passed that this committee be appointed.

The President announced that reports from the Treasurer, Board of Directors, Department of Missions and Church Extension, and Canterbury House would now be given. Also, that if Iolani School, the Priory, and Canterbury House wished to make oral reports they might do so.

In the absence of the Secretary of the Board of Directors, the Rev. Canon Paul Savanack read the report: See Page 33

The Treasurer, Mr. Henry Budd's report was next presented.

The Treasurer moved that the pledge of \$8,000 to the General Church be accepted. Motion was seconded by The Rev. Paul Wheeler, and passed.

Mrs. Clarence Lee, Assistant to the Treasurer, was asked to stand and be introduced.

The Venerable Norman Alter read the report on Mission and Church Extension. See Page 31

The President asked Mr. Vern Christensen of Ewa Beach to stand and be introduced to Convocation. Mr. Christensen has devoted untold hours in building the chapel for St. Barnabas, hours after his work day, and also devoting vacation hours on this project.

The Chaplain of Canterbury House, the Rev. Richard H. Humke summarized his report.

The Rev. Canon Richard Baker, St. John's, Guam was next introduced. During the past year

land has been purchased, a quonset building (purchased for \$10) is used for the Chapel. At present value rate it would be worth from \$8,000 to \$10,000. One of the local firms purchased two more quonsets; one for a residence, and one for a Sunday School building. These are valued at approximately \$4,000 apiece. A Marine Construction Battalion did some "training exercises" on the grounds -- with a bulldozer. Earth was leveled and moved, a parking lot was made. Some local firms have given various things toward building this mission, until now its present value is estimated at approximately \$36,000.

Canon Baker, in commenting on the native peoples, stated the population was mostly of Roman Catholic faith, but not a "committed" kind, rather in a "cultural" way. Two natives have been received into the Church this past year, and two others are attending. Further, Canon Baker stated, that within a matter of a few years, a number of people, native to Guam, will become dedicated Churchmen.

The Rev. Lamar Speier recently arrived on Guam to assist in the work there.

In closing, Canon Baker expressed appreciation for support from here, and translating a Guamanian expression said "God thanks you".

The Rev. Canon Charles Crane was asked to speak on Lenten projects. Canon Crane recommended each family read the Gospel of St. Mark during Lent. It is suggested that this Gospel be divided into 48 sections -- one for each day; have discussions on questions such as "What was the importance of Christ going into the wilderness for forty days?"

Canon McDonald began his report commenting particularly on teenagers, with the fact that there are those who honestly believe "youngsters should be buried when they are twelve, and dug up when they are eighteen and sent to college." He thanked the Bishop for the idea of having Church School Sunday. Canon McDonald spoke of the responsibility of a good private school, and the task of arousing scholastic appetites and increased loyalty to the Church.

Ground was broken for the Student Union Building last October, and students and faculty look forward to its completion. The design is excessively modern, allowing great flexibility for its use.

Canon McDonald will leave Iolani within a very short time, and Mr. James Pott will take over responsibilities for the present.

Sister Evelyn Ancilla reported for the Priory. The school is still short of classroom space; the recent building program indebtedness still exists, although substantially reduced this year.

The Priory has always used the Cathedral for its daily chapel services, and it is hoped this will continue through the years, however, there is great need for a school chapel large enough to accommodate an entire class. Such a chapel would be of spiritual value to small groups, or individuals who wished a place of quiet withdrawal. Present facilities are no larger than a household pantry, and the school "chapel" is backed and abutted by noise and confusion from within and without the building. The school is 91 years old, a small chapel surely seems justified.

Mr. James Taylor, Hawaii Preparatory Academy, was the next speaker. Mr. Taylor mentioned he was receiving numerous delegations while in the midst of preparing his report. (See page 22)

The Rev. Robert Sheeran made the following motions:

1. That the Minutes of the 57th Annual Convocation be prepared and submitted to Ecclesiastical Authority of the District for approval.
2. That an expression of appreciation be extended to Mrs. Raymond K. Hoefener for her assistance as Secretary.
3. That an expression of appreciation be sent to the Dean, Cathedral Chapter and Staff of St. Andrew's Cathedral for all they have done to assist with Convocation; to the Rector and Vestry of St. Peter's Church for the use of the Parish Hall for the Convocation breakfast.
4. That an expression of appreciation be extended to our Convocation Guests: The Rt. Rev. Horace W. B. Donegan, The Very Rev. John C. Leffler and Mrs. Leffler, and the Rev. Lemuel J. Winterbottom for the pleasure and inspiration they have brought to us at this 57th Annual Convocation.

Motions were seconded and approved.

Resolution concerning the Constitution of the Missionary District was presented by Mr. Arthur G. Smith as follows:

RESOLVED that Article I of the Constitution of the Missionary District of Honolulu be and the same hereby is amended to read as follows:

#### ARTICLE I

##### Title and Bounds of the Missionary District

This Missionary District is designated the Missionary District of Honolulu, and it embraces the Territories of Hawaii and Guam, and the Islands of Wake, Midway, Okinawa, Taiwan, and that part of Samoa known as American Samoa."

Motion was seconded and passed.

WHEREAS, there will be opportunity at the next meeting of the Legislature of the Territory of

Hawaii to express support of a serious need of the Territorial Department of Health; and

WHEREAS, the Governor of Hawaii has announced his personal feeling for the need of more preventive mental health facilities; and

WHEREAS, the Mental Health Association of Hawaii has called upon the Church for assistance in this area; and

WHEREAS, our Christian Faith compels us to exercise our influence and act for the prevention and relief of the ills of mankind in body, mind, and spirit;

NOW, THEREFORE BE IT RESOLVED that the Fifty-seventh Annual Convocation of the Missionary District of Honolulu, convening on the second day of February, 1959, go on record in support of the additional necessary Community Child Guidance Centers and the personnel to staff them; and

BE IT FURTHER RESOLVED that all clergy and laity of the Missionary District of Honolulu be encouraged to support this effort for the mental health of the children of the Territory of Hawaii by writing their personal feelings on the matter to Senators and Representatives and in any other way possible;

AND, BE IT FURTHER RESOLVED that certified copies of this resolution be sent to the Governor of Hawaii, the Senate and House of Representatives of the Territory of Hawaii, the Territorial Department of Health, the Division of Mental Health, and the Mental Health Association of Hawaii.

It was moved, seconded and passed that this action be done.

Another motion presented by the Rev. Mr. Grosh was:

WHEREAS, Norgren Bradley Allen suffered death from a tragic accident on October 10, 1958; and WHEREAS, he was a student for the ministry from the Missionary District of Honolulu; and

WHEREAS, he and his family were faithful members of Calvary Episcopal Church, Kaneohe, while he was on duty with the United States Marine Corps in Hawaii; and

WHEREAS, he served there as Lay Reader, Sunday School Teacher, and with his wife in many other capacities; and

WHEREAS, he was an outstanding example of the kind of men we seek for the ministry of the Church; and

WHEREAS, we mourn his loss to us both personally and in the Church Militant;

NOW, THEREFORE BE IT RESOLVED that the Fifty-seventh Annual Convocation of the Missionary District of Honolulu, convening on the second day of February, 1959, give recognition and honor to Norgren Bradley Allen, deceased;

AND, BE IT FURTHER RESOLVED that the members here assembled of the Church Militant commend Norgren Bradley Allen to the Church Expectant and Triumphant in the care and keeping of God Almighty by the mercies of our Lord and Saviour Jesus Christ until we may be re-united with him in Life Everlasting;

AND, BE IT FURTHER RESOLVED that certified copies of this resolution be forthwith transmitted to his wife, Mrs. Annette Allen, and to his parents, Mr. and Mrs. Howard B. Allen, with sympathy.

AND, BE IT FURTHER RESOLVED that the Secretary of this Convocation be instructed to record this resolution in the annals of said Convocation.

The Rev. Burton Linscott presented the following resolutions:

BE IT FURTHER RESOLVED that a certified copy of this resolution be forthwith transmitted to his widow, Mrs. Martha Souder, and family.

The Rev. Mr. Linscott also presented the following resolution:

WHEREAS, he represented our Church in community Christian Social Relations; and

WHEREAS, he was a recipient of the Bishop's Distinguished Service Cross of the Diocese;

NOW, THEREFORE BE IT RESOLVED by the Fifty-Seventh Annual Convocation of the Missionary District of Honolulu, convening on the second day of February, 1959, go on record to recognize his priestly influence upon the people of the Church and of the community at large;

BE IT FURTHER RESOLVED that the Secretary of this Convocation be instructed that this record be kept in the annals of said Convocation, and

BE IT FURTHER RESOLVED that a certified copy of this resolution be forthwith transmitted to his widow, Mrs. Grace Ozaki, and family."

Resolutions were approved.

Noon Day Prayers were offered by The Rev. Joseph Turnbull.

The Bishop gave the benediction, and meeting adjourned at 12:25 P. M.

Immediately following a service of dedication of two Pillars in the Cathedral was held, with luncheon following at Davies Hall.

EXCERPTS FROM THE BISHOP'S  
ANNUAL ADDRESS  
57th ANNUAL CONVOCATION OF THE MISSIONARY  
DISTRICT OF HONOLULU

Each year I have been your Bishop I have come to make my report to Convocation with a profound sense of gratitude to God for all those things which His Spirit has done among us. Much has been accomplished by you and your fellow Christians in this Missionary Diocese. This is good. That much remains to be done is just to say that we live in a dynamic growing society, which is going to present to us year by year, new problems and new opportunities and new tasks. Let us thank God for this; it is more fun than living in a situation which is not growing and expanding.

In both old and new congregations, as well as large and small, I sense a willingness on the part of people to do their share to maintain the Church and Ministry so that God's people may be cared for and spiritually fed. That is right.

Too often the effectiveness of the ministry in America is measured by statistical growth. I feel certain that He who spoke of the Lost Sheep and the Lost Coin does not judge our work in His Name.

1958 has been a good year for our Church in Hawaii. With 40 clergy in Hawaii, 2 on Guam, 6 on Okinawa and 4 on Taiwan, we have a fine group of men. 860 people were presented for confirmation in Hawaii. This is the largest number in the history of our Church in these Islands. Guam had 26, Okinawa 81, Taiwan 52, and the Military in the Far east 23, making a grand total of 1042 confirmations.

The total number of confirmed persons in Hawaii is 10,955, and Baptized persons 17,486. These totals are larger than for previous years, indicating that we have made some headway in the matter of Evangelism, although we still have much more to do.

The Church still has much to learn in this matter of Evangelism, the bringing of people to Christ. In the long run we need better prepared candidates for both baptism and confirmation. This will result in a stronger Church and in deeper devotion on the part of the people, and probably in increased numbers. We lose too many, due to lack of proper instruction, no follow-through of fellowship and interest on the part of the congregations in the newly confirmed. Adequate confirmation preparation is the concern of people, as well as priest and Bishop. They must be aware of the obligations and duties of a Christian and a Churchman.

Our schools - Iolani - Priory and Academy - are all doing exceptionally well; their enrollments are at an all time peak; Iolani with 970, the Priory 565, the Academy 116. Only lack of facilities keeps us from taking many boys and girls who wish to attend our schools.

I believe that we should have one Sunday each year in our Churches, called Diocesan Church School Day, when through sermons, talks and literature we present our schools to our people. This would be an opportunity to bring to our congregations the story of what is being done in these splendid institutions. I fear many of our people are unaware of the life and work of Iolani - Priory and Academy. We have over 3,000 boys and girls attending our Diocesan Parochial Schools every day.

Canterbury House at the University of Hawaii has taken on new life under the direction of our Chaplain, the Rev. Richard Humke. The students, with Canon Ault, this past year have improved the physical appointments. The Rev. Mr. Humke had the old building removed and work will start immediately on a new Canterbury Center. He wishes all Episcopal students from our Islands would register at Canterbury.

Congregations are making their principal and interest payments on time. It is a great struggle for some of our smaller congregations to keep their heads above water locally, and still meet their building obligations.

I hope some of our generous lay people will feel moved to help me to help these small places. In our families, if a member is sick, weak, or poor, we do not destroy them nor tell them to leave home. \$30,000 would enable us to eliminate all indebtedness in these small places.

We have poor congregations and congregations that are sick for one reason or another. The Episcopalians in Hawaii, if they would extend their giving a little, or divert their giving in the direction of our small congregations, would certainly be helping to lift a millstone and bring new hope and life to our discouraged people.

I have a man in Dallas, Texas, 85 years old, crippled with arthritis, living on a small pension, who every month sends us a check for \$10 to help, as he says, "The work of the Lord in the Pacific."

I wish that more of our people would be willing to do something special in the way of Church giving, over and above their usual support of the Church. The Diocese has no funds for advance work, we are paupers in this respect. Surely it would bring great joy and satisfaction to any Giver to know that he or she had a share in doing some special work and filling some great need, in the Name of our Lord.

The basic needs of the Diocese can only be met by a Capital Funds Campaign, if we are to be self-supporting in 1962. Precise projects and amounts should be carefully considered.

There are possibly two kinds of objections to such a campaign. The first relates to parish situations. Some congregations have recently held campaigns and are still in the process of paying pledges. I believe full consideration should be given to such local situations. I would, however, add that our Christian religion is a religion of unselfish vision. It only works on that basis.

On the other hand, Churches with no interest in others seem to fail in their own efforts. It could well be that a Diocesan Campaign would raise the sights of all and ultimately bless the local work of each congregation.

I have tried to remain objective about this matter. I have prayed and thought deeply about it for years. I believe that it is right and that it is possible. I feel that we will not only be stronger because of the funds we need so badly, but we shall be stronger for the very effort of being together. Working together in this great Christian enterprise, will bless us and our Churches. In the 100 years in the life of our Diocese we have never had such an appeal.

Each year I have mentioned tithing. I know that Christian Stewardship is the ultimate solution to our financial problems in the local Church, the Diocese and the Episcopal Church at large. The giving of a 5% tithe would do the job. It is not only a duty, but a way to discover in one's experience the joy of giving.

Have you ever met an ex-tither, someone who was once a tither and then gave it up to go back to some lesser form of stewardship. I have asked this question for several years and have never found an ex-tither. Why? Because tithers have come to experience a new sense of joy in their partnership in the Lord's work that tithing brings, and to know in their own lives the truth of our Lord's own words, that it is indeed "More blessed to give than to receive."

I commend tithing to you and urge each congregation to set up a committee to educate our people in the importance of tithing. Clergy cannot do it alone.

Your Will

I am ever grateful to those who remember the Diocese or a Parish in their wills. They are constantly in my prayers and I thank God for their thoughtfulness in providing for His Church after they are gone.

I read of people leaving property and sums of money, as gifts and endowments to their Alma Mater, pet Charities, to Social or Educational Organizations, to Hospitals and Schools and Colleges, but so often they forget their Church and Church Schools, Religious Institutions, Organizations and Missions. Secular institutions keep building up millions of dollars through such gifts, while the Church skimps and begs in order to keep the doors open, with no funds to build in order to advance God's Kingdom. It is true that you "Can't take it with you", but what a joy it must be to those who leave behind them gifts for the Master's work.

What a blessing it would be for the whole Church if our people remembered Christ by leaving gifts for something specific to: provide for Seminary Training for our young men, or build a Mission Church where people may find our Lord, or aid a Church School where children may learn about Christ, or endow a discretionary fund that will care for the sick, needy and indigents, who come to the Church in their distress. There are many ways you can help, if you really care enough to make the effort to put Christ first in your planning.

I would inaugurate at this Convocation "Operation Bootstrap" to lift ourselves up to a self-supporting Diocese. Begin by putting the Church in your will. Do it now! The amount does not need to be large in order to do this. See your attorney, or our Chancellor, Mr. Arthur G. Smith, or the Bishop, or your clergyman. But do it as soon as possible. If you have a will and have forgotten the Church - change it; if you do not have one, make one.

#### Bequest

One of the largest gifts made to the Church in Hawaii is the beautiful estate of Mrs. Katherine McGrew Cooper, at Makawao, Island of Maui. This eight and one half acre site with its beautiful large residence and other buildings is given with the request by Mrs. Cooper that it might be used for a Girl's Boarding School. We are grateful to Mrs. Cooper for this wonderful gift. She knew the need in our islands for a school of this type. Already parents of girls from all our islands are inquiring about this school.

## REPORT OF ST ANDREW'S PRIORY - 1958

### ENROLLMENT

This report covers the last half of the academic year 1957-8 and the first half of the current school year. The school has a capacity enrollment again this year, with a steady stream of applications coming in for the present year and the fall semester. The Priory is on the Navy's official list of schools in Washington, D.C., and the school's reputation seems to be as far-flung as our Nation's fleet, from the evidence in our mail bag.

### GRADUATES

The Priory graduated 52 girls on June 3, 1958. Forty-one of these are continuing their studies in college, nurses' training or business schools. One is attending an airline hostess school, one is with the armed forces, four are working in banks or offices in Honolulu, two are staying at home, and we have no information as to the occupation of three of the graduates.

### SERVICE PROJECTS

The Priory continues to believe that an important part of an education in a Christian school is the development of a strong sense of community obligation. The student body as a whole, as well as groups within the school and individual girls have taken part in numerous activities and service projects and for the Church, community and school. Clubs and classes are being influenced and encouraged to limit their social functions in the interests of service and scholastic attainment. We do not think that the latter is of value unless accompanied by the former.

Three University of Hawaii students each semester have done their Observation-Participation work in the Priory elementary school. In February the Diocesan Teachers' Institute was held at the Priory for the second consecutive year. Ninety percent of the student body has participated in a five year Tuberculin pilot study being conducted among the school children in this part of the city by the Oahu Tuberculosis and Health Association. The school sponsors a Welfare Fund that annually raises money to be prorated to the various financial drives conducted in the city, thereby contributing far more amounts than formerly when numerous smaller campaigns were held during the school year.

### RELIGIOUS EDUCATION AND GUIDANCE DEPARTMENTS

The school seeks to provide an all around education within a Christian environment. The religious education department and the guidance office implement this aim, but are not solely responsible for putting it into effect. Sometimes they act more as a hospital corps to deal with the casualties. A great many of our students experience a Christian community for the first time when they come to the Priory. They become aware of the Church as a new authority. Not all of them adjust easily, nor react favorably, therefore these two departments carry the burden of interpretation of the faith in general and of Christian living in particular situations. All our teachers are expected to share in this work of interpretation and counselling as much by what they are as by what they say and teach. However, the chaplain, school counsellor, and the teachers in the religious education department are the referral centers for those students who require more time than a busy classroom teacher can give to any one child.

Of the entire student body 61% have been baptized and 33% confirmed. In the present senior class 95% are baptized and 79% confirmed. This has been a consistent pattern over the years. As the girls grow to maturity in the school they tend to accept the faith for themselves. Our aim is to see them firmly established in a parish where they will continue after their school days as faithful communicants and loyal members of the Church.

#### IMPROVEMENTS

The science laboratories on the first floor of ASCENSION HALL, our newest building, were completed, equipped and ready for use in January. In addition to the two laboratories, one for classes in chemistry and the other for biology and general science classes, there is an adjoining lecture room.

An additional fire escape was added to the main building on the recommendation of the fire inspectors, and the black topped area of the school grounds was increased for the convenience of the physical education classes.

#### BENEFACTORS

The Connecticut Branch of the Woman's Auxiliary gave us a generous monetary gift towards the purchasing of science equipment for our new laboratories, as did our own Honolulu Branch of the Woman's Auxiliary, now the Episcopal Church Women in Hawaii. We are grateful to both these branches for this assistance. Other individual donors have also helped in the acquisition of the expensive equipment needed for the science department.

#### CURRENT NEEDS

Our debt for our recent building program is still with us, although substantially reduced in this year. An increase in tuition definitely allocated to the building fund is the chief means of clearing this debt.

In spite of our new building we are still short of classroom space. Our first grade is housed in a frame structure that was pronounced unsafe last summer. It has been shored up, reroofed, re-floored and had its walls patched and painted, but obviously its future is limited.

The Priory has always used the Cathedral for its daily chapel services and we hope that this will continue through-out the generations ahead. However, it has been a great inconvenience to the school not to have a chapel on the school campus large enough to accommodate an entire class at a time. Such a chapel would not only be of spiritual value to the student body and faculty but would be available to small groups or even individuals who wished a place of quiet withdrawal on occasion to renew their strength. Presently this is a dream rather than a plan, but it is a need of the school.

#### ACKNOWLEDGEMENTS

We take this opportunity to express our gratitude to Canon Frederick A. McDonald, Rector of Iolani School, for permission to use their chapel for our Commencement service last June; to Mr. Manual Kwon, principal of Central Intermediate School, for the use of their school auditorium and grounds on several occasions; and to Dean Cox, the Cathedral Chapter and staff for their patience and hospitality towards the school. To the Bishop and Diocesan office workers we extend our heart-felt thanks for all their aid and comfort to us through-out the year.

#### REPORT OF THE HAWAII PREPARATORY ACADEMY Convocation 1959

#### GENERAL STATEMENT

Though various delays have prevented our being able to be as far along in our building program as we had hoped, the new site has now been completely bulldozed and is ready for building. Con-

struction drawings are in process; and this time it is an absolute must that we have two dormitory buildings along with temporary kitchen and dining facilities ready by September. The athletic fields should be ready before that. In the meantime we are again enjoying what we regard as an outstanding year on all fronts.

#### ENROLLMENT AND ADMISSIONS

Our total student enrollment this year is one hundred and sixteen, with ninety-four boarding students and twenty-two day students. Again we had to add temporary constructions to our old campus in order even to begin to meet the demands. Though we disliked transplanting used constructions to the old campus, we felt that it was important for the development of the school to take on the twenty-four boys over the previous year's enrollment which it permitted. Next year, we hope to be able to take one hundred and five boys altogether. This again means that we are going to have to turn down a good many applicants, but we shall continue to give every possible and careful consideration to each candidate.

#### IOLANI SCHOOL THE RECTOR'S REPORT

November 1958

Iolani's chief responsibility has been to prepare young men to enter college. The very high percentage of Iolani graduates who go on to higher studies is witness to the effective way we are fulfilling the school's primary mission. Today, we are planning for a deeper involvement of the bright student in Science, Foreign Language, History, Mathematics and English. We have available for distribution a statement on our curriculum which shows just how far an earnest student may go in the high school course here, and we believe that no secondary school in Hawaii duplicates this program.

On a broad scale we are schooling our boys soundly in the essentials. A good private school must do more. A private school truly sensing its responsibility will try to challenge the gifted student progressively and excite his interests in special fields to an exceptional degree. We are trying to do this in many ways, particularly through our honors tutorial program and arrangement for advanced classes when the desire for learning at a deeper level is really there.

We have students so interested in Latin and Mathematics that in the Junior year they have already accomplished four years of study in these areas and wish to advance to a fifth year. Having aroused these scholastic appetites we are committed to seeing to it they are satisfied.

#### FACULTY

It is a joy to report that we have scarcely one-third the turn over of teachers compared with the situation of two or three years ago. We are proud of the seven new teachers whom we have, as well as the two who have taught previously at Iolani and have returned. The School already has application from some exceptionally strong teachers when a vacancy opens. It is the hope of this administration that from now on they will be at a minimum.

#### ADMISSIONS

There are 967 boys enrolled in the School, 341 in the elementary school and 626 boys in the upper school.

An important change was made this year in reducing the first grade to one section and enlarging the sixth grade to three sections. The people of Oahu seem to find their needs best met by Iolani School in grades four through twelve. With the large number of parish schools of the Episcopal Church presently under way or contemplated, it may be that Iolani should shift its educational emphasis upwards.

It has been an embarrassment to have to turn down boys, who for reasons of churchly interest, family school connections, or genuine ability, we would like to have taken, but could not accept for the sole reason that we do not have the room.

More than ever before the school reflects in its student personnel much the same proportions that one finds in the Island populace.

#### PARENTS

Never before have the parents seemed to be so thoroughly responsive. An initial meeting of the fathers and mothers of all new boys was held in the Chapel one night in August. The Chapel nave was almost entirely filled. Both Parent-Teacher Groups are very effectively organized. The 1959 carnival has been accepted with enthusiasm, assignments have been made early and there is promise that it may be the largest carnival the School has ever had.

#### THE STUDENT CENTER

Ground was broken for this building on Friday, October 3, the fourth anniversary of the dedication of the Chapel. It was a very big Iolani day. Members of the staff, officers of the Student Body, the oldest teacher in line of service, and the newest boy to enter the school, all took their turns in shoveling a spade full of earth.

It is my hope that, if the carnival proceeds are high enough, we will be able to erect the building, have it furnished with kitchen equipment, tables and chairs without having to go to the bank. The dream of this building has fascinated the students and all are looking forward to its completion.

#### OUR CENTENNIAL

1962 is Iolani School's centenary year. Ours is the oldest Episcopal Church School west of the Rocky Mountains. neglected for much of its history as a "missionary school" I am certain that Iolani is destined to be a name of great importance in the future. We should have achieved a capital funds drive by December 31, 1960 so that we shall be able to have completed the school plant when we celebrate our 100th birthday in 1962. At that time, with continued improvements in

curriculum and standards, I hope we will have the strength to demonstrate to Hawaii and the bordering countries of the Pacific the superior contribution which a church school can make in the development of the next generation.

#### ARMED FORCES CENTER AND DIOCESAN HOUSE

The year 1958 rolled by very smoothly in the Armed Forces Center and Diocesan House, although there were quite a good many changes. A completely new group of service men came in during the middle of the year. Several of them were Episcopalians and several of the others have become interested in the Church. At present we have Sunday School teachers, acolytes, and men going to the Confirmation classes.

The Seabury Fellowship has a very active group this year, and a lot of their social life is in the Diocesan House. They meet every Sunday night, but occasionally on other nights they have suppers or group singing.

While the Hostess was on the Mainland, the Diocesan House had its face lifted, so to speak. Beautiful floors were put in downstairs, walls and woodwork painted by the Mens' Club, and all of the chairs, punes and pillows recovered by the ladies. Not to be outdone the Hostess and some of the young service men painted all of the upstairs' woodwork, walls and ceiling of one bedroom and fixed up the hall to make it more attractive. The ceiling of the hall and the floor and banisters were then painted by a painter. The House was then put under the big tent and determined, so now we are in good condition.

We still are full every weekend and have men staying there on leave from five to thirty days. Several of them are going to college at night and find the quiet of the House conducive to study.

The various organizations of the Diocese and the Parish hold their meetings in the Diocesan House, and it is felt that the House fills a need in many ways.

Naturally Canterbury House operates more on a September to June basis than on a calendar basis. I can speak only sketchily of the first part of 1958 for I was not present at Canterbury House. Worship services and meetings were held; the group had projects to raise money; the place was open as a center for students to come between classes.

In the summary of 1958 work on the interior of the main building at Canterbury House was done and the work on the pavilion at the back of the House was completed. This presented an adequate structure to resume our work when school began in September.

We have approximately 50 students using Canterbury House this year in varying capacities. This does not mean that 50 students come to Canterbury Club meetings twice a month for this is but one aspect of the program. There are some things which attract some students while other things attract other students. If a distinction is to be made between a Canterbury House and a Canterbury Club, it is this distinction: the Club is but one part of the program of a Canterbury House.

Each Thursday morning at 7:40 a worship service was held; on one week it would be a celebration of the Holy Communion, on the other week Morning Prayer would be read. Twice a month Canterbury Club meetings were held on Friday evenings. An attempt - not especially successful - was made to have a program of some sort at this meeting. Supper was served usually; a business meeting followed, and then recreation.

The group joined in campus projects and Church projects. They participated in the Club Night at the beginning of the year to interest new students and were able to come away with First Prize

for their display. They collected juices at Thanksgiving time for the Mentally Retarded Children's Association. They worked on a service project for the Tuberculosis Association. At Christmas they sang carols at a number of places, including the King's Daughters Home and Leahi Hospital.

Toward the end of the year a discussion group was formed of six or seven students who were interested in meeting once every other week to discuss, and learn about, the Christian Faith.

The end of 1958 saw the beginning of the end of the present Canterbury House and plans for a new building to be put up in 1959.

I see specific areas which we ought to emphasize for 1959: (1) Interest more outer island students in Canterbury; (2) Make Canterbury more racially representative; (3) Attempt to reach Episcopal students at the University who have graduated from public high schools and other than our Church private schools; (4) Try to make Canterbury House more obviously an Episcopal center with its emphasis toward serving those who are Episcopal students and those who are interested in the Episcopal Church - as opposed to those who are merely interested in the Center which the Episcopal Church maintains; (5) Discourage the use of the work "Club" and its attendant exclusive feeling so that we might serve more of our own students.

If only beginnings could be made in these areas in 1959, it would be encouraging.

#### REPORT OF THE DEPARTMENT OF CHRISTIAN EDUCATION

In recent years there has been a revival of interest, study and effort in the whole field of Christian Education. This has been true all over the world and in practically every Denomination of Christendom. Our Church has been one of those most affected. Within the last ten years our National Department of Christian Education has grown considerably; the first official publishing house of the Episcopal Church, Seabury Press, was established: many books and materials for the Christian Education of young and old have been published.

You will see these facts reflected in the Division reports:

ADULT DIVISION  
The Rev. Richard A. Kirchhoffer, Jr.

Our National Department of Christian Education has published, through Seabury Press, many books, pamphlets, and study guides for adult Christian Education. We have purchased copies of most of these, and they are available for reference in the Library of St. Andrew's Cathedral. We stand ready at all times to assist clergy and laity in the selection and use of these materials, and we will be glad to recommend other materials that may be needed.

This Division was also responsible for the 1958 Diocesan Lenten Family Worship Program. Extra copies of FORWARD--Day by Day, the daily devotional booklet of the Episcopal Church, were ordered for all of our Parishes and Missions, and we printed "Suggestions for Family Worship" to go with these to each family.

CURRICULUM DIVISION  
Sister Evelyn Ancilla, C. T.

This division seems to be a supernumerary now that the Seabury Courses are available and in use, and the period of the "Interim Curriculum" is over. The impracticality of keeping samples of curriculum material on hand in the Diocesan Office has brought another responsibility of this division to an end. Presently its chief duty would seem to be as a liaison officer between our Church schools and the Hawaiian Evangelical Association Book Rooms, the place where samples of all our Church school courses are kept in their most recent form or edition. This has proved to be a far more satisfactory arrangement than the former method. The Book Rooms are at 2103 Nuuanu Avenue, and Miss Evelyn Fitzsimmons, a member of our Church, will give one every assistance.

AUDIO - VISUAL AIDS DIVISION  
Sister Lois Mary, C. T.

The following are the additions made to the film library in the past year:  
16mm motion picture produced by the Virginia Theological Seminary on Seminary life.  
Three filmstrips produced by National Council of Churches (Church World Service): "Exiles in

the Holy Land" with script and record for young people and adults; "Wait a minute" for junior highs and "Travelin' Man" for younger children to encourage giving to Church World Service.

The 1958-59 Audio-Visual Resource Guide was added to the department as an aid in ordering films.

PROJECTS DIVISION  
The Rev. Charles T. Crane

This Division was responsible for promotion of the Church School Missionary Study in Epiphany or Lent, the Church School Missionary Offering (Mite Box), and the Birthday Thank Offering.

The 1958 Church School Missionary Study materials emphasized The Missionary District of Salina (Kansas) and our negro work in Haiti and on the Mainland. We cooperated in our Church's international Poster Contest on these themes, and we conducted a local Poster Contest as well.

The 1957-58 and 1958-59 Birthday Thank Offering theme emphasizes our work among the Navaho Indians and is helping to build a Community Center at San Juan Mission, Farmington, New Mexico. Birthday Thank Offering materials were ordered and made available to all who had not ordered direct from the National Council.

PAROCHIAL AND PREPARATORY SCHOOLS DIVISION  
The Rev. Burton L. Linscott

In connection with Convocation 1958, our Second Annual Teachers' Institute for Episcopal Schools in the Hawaiian Islands was conducted. The Institute began with a celebration of the Holy Communion by the Bishop and his greeting of the assembly. The Keynote Address: "What Relevance Has Christian Community to the Whole Process of Education" was given by the Rev. Dr. Shelton Hale Bishop. (This address has been printed and distributed to the teachers in all of our schools and is available at the Bishop's Office.)

The rest of the morning was devoted to Workshops for teachers according to department: Pre-school-Primary, Elementary, Intermediate, and Secondary. Chairmen, respectively, were: Mrs. Mary L. Turner, Mrs. Ruth Morrell, Dr. William D. Lampard, and Dr. Robert W. Clopton. Resource Persons were: The Rev. Messrs. Paul Wheeler, Arthur Ward, Wai On Shim, and the Very Rev. James S. Cox. Recorders were: Mrs. Henry Bartels, Mrs. William Yount, Mr. Charles Halter, and Mrs. Margery Kekauoha.

An afternoon inspirational address was given by the Very Rev. Paul Roberts; summaries of the Workshops were read by the Recorders, and the Evaluation and Closing Address were given by the Rev. Dr. Shunji F. Nishi. The meeting was closed with the Bishop's Benediction.

We are most grateful to all who took part in this institute, and we owe special thanks to St. Andrew's Priory for serving breakfast and lunch.

LEADERSHIP TRAINING  
Mrs. Mary Lou Turner

The Chairman of the Department welcomes the opportunity to write this section of the report for Mrs. Turner, who is temporarily on the Mainland, because we feel that our greatest strides in 1958 were in Leadership Training. All members of our Department assisted in the Leadership Training Conference, June 12-17, for Clergy and Lay Leaders throughout the Diocese, meetings being held on Hawaii, Maui and Oahu. The Leadership Training Team from our National Department of Christian Education consisted of: Miss Mary Louise Villaret and the Rev. Messrs. Alfred Persons, Francis Voelcker, John Midworth, and A. Donald Davies. The Rev. Dr. David Hunter, Director of the National Department, passed through but did not have time to participate in the Conference. Your Chairman did have the opportunity to consult with him.

Follow-up on this Conference indicates improvement both in quantity and quality in our Parishes and Missions in the areas of Sunday School Teacher recruitment, training, and supervision, selection and use of materials, and in Adult Education.

In September, we arranged a meeting of clergy and laity to hear a talk by Mrs. Virginia B. Haley and to see a movie on the work of our Church through St. Paul's (Rikkyo) University, Tokyo. Over 20% of the students become Christians while at St. Paul's.

REPORT OF THE CHRISTIAN SOCIAL SERVICE DEPARTMENT

Christian Social Service was carried on in the Missionary District in several ways on the individual, Parish, and Diocesan levels. The Clergy, of course, continued their pastoral calls at hospitals, as well as their special work at institutions such as the Territorial Hospital, Kaneohe, and the Kalaupapa Settlement on Molokai. Both Clergy and Laymen have served on committees and boards of many local civic and welfare groups in the name of the Church.

Many Sunday Schools report their children having participated in either the S.O.S. or U.N.I.C.-E.F. Halloween programs to send surplus food and medical supplies overseas. Several also gave foodstuffs at Thanksgiving and white gifts at Christmas for needy families. Oahu Sunday Schools, and many on the other islands, gave offerings of canned fruit juice for the several island Mentally Retarded Centers.

Young people's, Men's and Women's groups report sending large amounts of clothing to the Far East and other areas, supporting Mentally Retarded Centers, collecting toys for hospitals, entertaining servicemen at the Armed Forces Y.M.C.A., etc.

On the Parish level many congregations held special offerings for the Presiding Bishop's Fund For World Relief, while a number worked to collect old clothing for world relief. Several Parishes and Missions sponsor Scouting programs, several have made their facilities available for use by various health and welfare agencies.

With the formation of a World Relief Committee as a part of the Department, efforts have been made to unify the relief work of the Parishes and Missions throughout the District. Some results have been obtained already -- especially through greater participation in the S.O.S. program, and through increased contributions to the Presiding Bishop's Fund for World Relief. Plans were begun in late 1958 for a Diocesan wide clothing drive to be held in early 1959.

The Department, with the entire Missionary District, feels very keenly the loss of The Reverend Lawrence H. Ozaki, our former director.

REPORT OF THE PRESIDING BISHOP'S COMMITTEE ON LAYMEN'S WORK  
THE LAYMEN'S LEAGUE IN HAWAII

May I give you a report of our diocesan laymen's activities for the year 1958.

- (1) The Annual Men's Corporate Communion Services were observed on Washington's Birthday, February 22, 1958, on the island of Oahu, Holy Communion Services followed by breakfast meetings were held at three designated churches.  
(a) City of Honolulu, St. Andrew's Cathedral.  
(b) Windward, Oahu. St. Christopher Church, Kailua.  
(c) Leeward, Oahu. St. Stephen's Church, Wahiawa.

The attendances showed an increase over the previous year. The special offering collected at this service was designated for our Conference Center at Mokuleia, Oahu, which our Laymen's League is responsible. We collected about \$1,800.00 from this service.

- (2) In cooperation with the Honolulu Council of Churches, the Episcopal laymen furnished cars every Sunday in the months of January and February, 1958, to transport servicemen who wanted to go to church in Honolulu. About 12 of our churches participated in this project.
- (3) The Annual Laymen's Training Program was held at the Mokuleia Conference Center, Oahu, on September 20 & 21, 1958. Mr. Art Caswell, Parish Keyman from the Holy Nativity Church in Honolulu was the leader. Mr. Caswell attended the Provincial Laymen's Training Course held in Reno, Nevada, in the month of May, 1958. Thirty delegates from our churches attended the training program and it was well received.
- (4) The chairman on laymen's work of the Eighth Province of our Church, Mr. Stephen C. Shadegg visited Hawaii in the month of November, 1958. At a dinner-meeting held at the St. Clement's Church, about 100 persons had the opportunity to hear a great and inspiring message from Mr. Shadegg.
- (5) As our Laymen's League is responsible for the maintenance and repairs of Mokuleia Conference Center, the laymen from all our churches have contributed some time during the year in carpentry work, painting, and other necessary work to the buildings and other facilities of the Center. I want to thank Mr. David Thorndike, Chairman of the Mokuleia Camp Committee for the great share of work he did in coordinating the work at the Center.

In closing, I would like to express my gratitude and sincere thanks to the Bishop, the members of the clergy, and the parish keymen for their counsel and assistance during the year. I also want to thank our laymen for their participation in the activities of the Laymen's League.

REPORT OF THE DEPARTMENT OF YOUTH

The Diocesan Department of Youth in conjunction with the House of Young Churchmen Council (HYC) and the various churches Junior Episcopal Churchmen (Jecohs) and Episcopal Young Churchmen (EYC) carried on a well rounded program of Worship, Study, Service and Recreation during 1958. Department members served as advisors to the respective groups. The Chairman of the department served as advisor to the HYC Council. The Rev. Robert Sheeran as advisor to the Jecoh Council and the Rev. Norman Ault as advisor to the EYC Council. The Archdeacons of the other islands served as liaison between their churches Youth Groups and the Diocesan Councils. Mrs. William Koch planned and supervised the Summer Camp program at Mokuleia with the Rev. Norio Sasaki as Camp Director.

The year's activities commenced with the HYC banquet at the Reef Hotel Feb. 7th and 8th when over 400 attended to hear Bishop Lewis of Nevada, Chairman of the National Council's Division of Youth. Saturday, 128 spent the day in conference at Mokuleia.

The 7th and 8th graders met on Saturday at the Reef Hotel and organized themselves into the Jecoh's, Junior Episcopal Churchmen of Hawaii.

We owe a debt of gratitude to Mr. & Mrs. Roy Kelley of the Reef Hotel for their many kindnesses and cordial hospitality to our young people in planning the annual Youth Banquet, dance and conference sessions.

The national observances of Episcopal Young People, i.e., Youth Sunday, Youth Offering, Lenten



Study, Feast of Lights, Student Day of Prayer and Youth Communion Sunday, were observed throughout the islands by our young peoples groups.

Youth Conferences or Summer Camps were held on the islands of Oahu, Hawaii, Kauai, and Maui. We are grateful to the Summer Works Project of the Diocese of Los Angeles for sending us 12 excellent Camp Counselors, who served at Mokuleia and Camp Pecusa. Total island wide attendance was 372.

It is of interest to note that many of the local church groups have given of their time, labor and money toward the betterment of our Conference - Camp Centers. We urge more groups to do so thus helping not only to reduce the cost of maintenance but creating a vital interest in these centers to be used throughout the year.

The Jecohs held a conference at Mokuleia June 15 to 20 with 43 in attendance. They also, on Oahu, held a summer and New Year's Holiday dance.

I urge clergy and advisors to avail themselves of the material issued by the Division of Youth as aids to their youth work. These are the EYC Notebook for High School and the new Junior Hi Notebook.

Since the individual churches report directly their respective Youth Sunday offerings we have no idea of the total amount.

In the field of Christian Social relations all youth groups on Oahu participated in the Canned Juice Thanksgiving offering for the M R Centers sponsored by the Hawaii Association to Help Retarded Children. Sufficient was collected for a year's supply for the 8 centers.

The Department Chairman would appreciate, in the year to come, all youth groups sending in reports of their programs and activities so that we can, at the next Convocation, present a more comprehensive picture of our churches Youth Work in the Territory of Hawaii.

#### REPORT OF THE DEPARTMENT OF MISSIONS AND CHURCH EXTENSION

The Department takes pleasure in reporting the following achievements in 1958:

The holding of services in the Kona Inn, Hawaii, for people in the Kailua area.

Additions and improvements to property:

ST MARY'S MISSION, HONOLULU - A new parish hall erected and dedicated at a cost of \$47,000. Moving and remodeling the Church, Rectory, and other buildings, putting in fill and landscaping at a cost of \$25,000.

CALVARY CHURCH, KANEOHE - Starting the erection of a new church building and furnishings at a cost approximating \$75,000. An organ has been given to the Church by Mr. Charles Pietsch at a cost of \$6,000.

HOLY NATIVITY CHURCH, AINA HAINA - New Youth Center erected and dedicated at a cost of \$170,000. A new classroom added to the Educational Building at a cost of \$3,500.

EPIPHANY CHURCH, HONOLULU - Starting the extension of the church, new chancel, choir room, sacristy. New classroom unit, with six classrooms, offices, study, storage and lavatories; purchase of new Vicarage and property, at a cost of \$140,000.

ST. ANDREW'S CATHEDRAL, HONOLULU - Completion of the nave of the Cathedral and dedication of it at a cost of \$400,000. Blessing of the new fountain, the gift of Mr. and Mrs. Robbins B. Anderson.

ST. ELIZABETH'S CHURCH, HONOLULU - Completion and dedication of an Educational Building and Parish Hall at a cost of \$65,000; construction and dedication of a rectory at a cost of \$25,000.

ST. MARK'S CHURCH, HONOLULU - Completion and dedication of a new educational building at a cost of \$45,000.

ST. PETER'S CHURCH, HONOLULU - Completion of the church chancel improvements at a

cost of \$6,543.44. Installation of a new pipe organ at a cost of \$20,663.46.

ST. TIMOTHY'S CHURCH, AIEA - A new Vicarage at a cost of \$26,500; a new parking lot at a cost of \$1,600.

ST. CLEMENT'S CHURCH, HONOLULU - Improvements to the church and parish hall at a cost of \$1,600.

CHURCH OF THE GOOD SHEPHERD, WAILUKU, MAUI - Improvements to the church at a cost of \$3,000. New pews for the entire church, gifts of individuals.

We have the largest number of men in the history of our Islands studying for the ministry in our seminaries - ten in all. Two are Candidates for Holy Orders.

Services are being held at Laie, in the homes of our members. Plans are now being made to acquire land and erect a small chapel.

We have a great need for a Filipino priest to minister to people who have moved here from the Philippines and who are members of the Filipino Independent Church.

We are moving into a new church at Ewa Beach.

We have a great need for the establishment of a fund to purchase of land in strategic areas. Our small Episcopal Construction Fund is available only for loans.

We have made a step forward in sending another priest to Guam to help with our work.

During the calendar year 1958 your Board prepared the examinations required by the Canons for Mr. Norio Sasaki. Mr. Sasaki took these examinations under the supervision of the Church Divinity School of the Pacific. After scrutiny the Board informed you that Mr. Sasaki had successfully passed his examinations and had met the requirements for ordination to the Diaconate and the Priesthood.

Similar examinations were prepared for Mr. Iver J. Torgerson, Jr. These will be administered at a later date by the Virginia Theological Seminary.

A similar request has come from Mr. Roger M. Melrose of the Church Divinity School of the Pacific and this will be a responsibility of the Board appointed by yourself for 1959.

The general pattern of the work of the Episcopal Churchwomen of Hawaii does not vary greatly, but their spiritual and religious understanding, concern for the needs of others, and expanding and widening vision of the work of the whole church, shows a healthy growth with the passing of each year.

Inspirational devotions and short informative programs are a vital part of the monthly Executive Board Meetings and have been designed also to be a guide for planning parish and mission programs. The active participation of the women has made it necessary to increase the length of the meetings. We now start at an hour earlier and follow the meetings with an informal luncheon and fellowship hour, thus enabling the women to continue with their exchange of ideas to further the work of the church.

The 'new look' of the Diocesan House is a pleasure for all to behold. We are particularly grateful to Mrs. Eric Wakefield and her energetic and faithful helpers who worked hard to brighten this gathering place which is used so constantly by all of our diocesan family.

The altar Guild had its usual number of requests throughout the year. A very small, but devoted group of women worked together each Tuesday morning to help fill the requests not only for our local missions, but also the requests from our missions in the far Pacific; Guam, Okinawa and even little Christmas Island. The beautiful altar linens produced by these women, in a tangible way expresses their love for our Lord.

The 1958 National supply assignment was a tremendous one, and upon completion, was forwarded to the Paiute Indians of St. Mary's Mission, Nixon, Nevada and St. Michael's Mission in Wardsworth, Nevada. Women on the neighbor islands did their share in this yearly Lenten project. The women on Oahu worked on the assignment five Fridays during Lent. The 'Chain of Prayer' is an adjunct to this yearly Lenten project. Meditations based on the Rt. Rev. Everett Jones' address on "His Witnessing Community" were prepared by the Devotional chairman. The January-February issue of CHURCHWAYS published an account of the Honolulu Lenten program as a suggestion to other women throughout the church. Japan was the adult study recommendation for 1958 and we were most fortunate to have the Rev. Dr. Shunji Nishi and Mrs. Henry Budd present their views of Japan as part of the Lenten program.

The women are interpreting the meaning of Christian Social Relations, particularly in their work with the Armed Forces YMCA and the Oahu Health and Tuberculosis Association. As groups and as individuals they are answering the needs of the community in their service to the Territorial Hospital, to Waimanu Home and to many other needed areas throughout the community and the world. They are participating in the program of the United Churchwomen and are kept well informed of its projects through Mrs. Henry Caldwell, president of this ecumenical council. The Mothers' Memorial Fund continues to assist two retired women church workers and has assisted those faced with sudden illness.

The Church Periodical Club has grown considerably in its missionary effort. \$190.00 was contributed to the National Book Fund, \$165.00 of which was for books for our postulants and candidates for Holy Orders. Two delegates attended the Triennial Meeting of the CPC in Miami, which met three days prior to General Convention and with the new ideas they have brought home, we look forward to greater advancement in the work of the CPC. On the homefront the women have collected and distributed magazines to hospitals, rest homes, shut-ins and the Seamen's Institute and have augmented religious libraries.

The whole-hearted cooperation of the women made it possible to have a full delegation attend the 29th Triennial Meeting in Miami Beach, Florida. It is hoped that the inspiration and vision of the opportunities and responsibilities of service, as presented at the Triennial Meeting, will reach out to all women of the diocese.

The United Thank Offering continues to grow as more women sense the opportunity and privilege of sharing their daily blessings with others throughout the world. Mrs. Harold Shim presented the offering for the women of Hawaii and Guam at the United Thank Offering Service in Miami Beach, Florida. Our total offering for the past triennium was \$17,100 - up \$4,000 over the last triennium which reflects an increase not only in amount contributed, but also in the number of participants.

Although this is but a brief summary of the work accomplished throughout the year, it illustrates the emphasis given to the Bishop's objective for the women for the year 1958.

Gentlemen:

We have examined the balance sheet of The Protestant Episcopal Church in the Hawaiian Islands, as of December 31, 1958. Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

The accounts and records of the church do not reflect the financial position and results of operations of parishes, missions, and institutions which conduct the activities of the Protestant Episcopal Church throughout the Territory of Hawaii. However, certain trusts of these departments are held by the church, and accordingly have been taken into account in the accompanying financial statements.

Inasmuch as title to all real property, except the real property of Iolani School and St. Clement's Church, is vested in The Protestant Episcopal Church in the Hawaiian Islands, this property is accounted for in the records of the church. However, the carrying value of the real property is not infrequently an estimated amount, not readily subject to accurate determination, intended to represent expenditures made not only by the church but also by missions, parishes and other persons, or, more recently, an amount which represents only those expenditures made from the proceeds of loans from church funds or lending institutions which do not include certain other expenditures made through the treasurer's office or directly by churches and parishes.

In our opinion, the accompanying balance sheet and supporting schedules have been prepared in accordance with established accounting practices of The Protestant Episcopal Church in the Hawaiian Islands on a basis consistent with that of the preceding year.
