

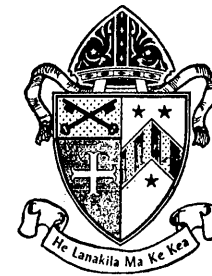

MINUTES OF THE FIFTY-EIGHTH ANNUAL MEETING  
OF THE  
MISSIONARY DISTRICT OF HONOLULU

Monday, February 15, 1960

Holy Communion in St Andrew's Cathedral preceded the business meeting of the 58th Annual Convocation of the Missionary District of Honolulu. The Bishop, The Rt Rev Harry Sherbourne Kennedy, was Celebrant, assisted by The Very Rev James S Cox, The Ven Charles T Crane, The Ven Gerald P Loweth, the Rev John J Morrett, the Rev Morimasa Kaneshiro.

Breakfast was served in St Peter's Parish Hall.

The business meeting of Convocation was held in Tenney Hall. The Bishop presided as President, and called the meeting to order at 9:30 A M.

The Rev Canon Wai On Shim was appointed Secretary Pro Tempore, and read the Roll Call of clergy canonically resident in the District. Roll Call of Lay Delegates was read by The Rev Norman C Ault.

The President declared a quorum present.

It was moved by The Rev Norman R Alter that The Rev Canon Wai On Shim be nominated as Secretary of the 58th Convocation, and that a white ballot be cast in his favor. Motion was seconded and passed.

The Rev Mr Allen T Osborne from Oregon was introduced. Mrs Eliza Spencer of Hawaii was introduced. Both The Rev Mr Osborne and Mrs Spencer were asked to stand and be recognized.

The Rev Norman R Alter moved that the courtesy of the floor be extended to The Rt Rev James A Pike, Bishop of California, and to The Rt Rev Lewis Bliss Whittemore, Retired Bishop of Western Michigan.

It was moved by the Rev Canon Paul R Savanack that messages be sent to the following: The Rt Rev and Mrs S Harrington Littell, Bishop Retired, The Ven James Walker, The Rev Canon William Heffner, Chaplain Kenneth D Perkins. Motion was seconded and approved.

The following message from Okinawa was read: "BISHOP KENNEDY PECUSAM HONOLULU: OKINAWA SEIKOKWAI SENDS GREETINGS TO HONOLULU CONVENTION /s/ HEFFNER.

The President introduced new clergy who had arrived in the District since last Convocation as follows: The Rev Roger Melrose, and Mrs Melrose; The Rev Geo Quarterman, and Mrs Quarterman; The Rev Burton MacLean, and Mrs MacLean; Canon Charles P Gilson, The Rev Timoteo Quintero, The Rev Reginald Rodriguez; The Rev Iver Torgerson, and Mrs Torgerson.

The next business concerned delegates to the Synod of the Province of the Pacific. This will be held at St Paul's Cathedral, Los Angeles May 2-5, 1960. It was moved, seconded and passed, that the Chair be authorized to appoint delegates who may be available to attend the meeting.

Fixing the date of next Convocation was the next order of business. This date was set for February 5, 1961. Motion was made, seconded and passed that the date be approved.

The Treasurer, Mr Henry F Budd Made his report. See Page 56. \_\_\_\_\_

Due to the illness of Mr Herman V von Holt, the President reported for the Secretary of the Board of Directors. See page (21).

Mr Arthur G Smith moved that the report be accepted subject to audit. Motion was seconded by Dean Cox, and carried.

Sister Evelyn reported for St Andrew's Priory. She began by saying that the vital statistics were listed in her written report; the dramatic episodes were between the lines. The Priory has some 600 girls, 40 teachers, and other woman workers. She spoke of the parents of daughters who attend the Priory as receiving the fruits of the Faith, not the roots of the Faith. The Priory still lacks a Chapel on Campus. For this project, they had \$100 last year; they now have \$3,893.

The Headmaster of Iolani was introduced, The Rev Burton MacLean. The Rev Mr MacLean stated that Iolani is dedicated to the goal of giving her boys the finest possible preparation for college, for life, and for leadership in Church and Country. To achieve this, the School is committed to standards of academic and moral excellence.

Academic excellence cannot be achieved without moral excellence. Academic achievements have their roots in the honest mind. The honest mind can be cultivated only in morality, and morality has its sure roots in the Christian faith.

There will be an increase in tuition in order to assure top flight faculty. A development program is underway, this to be accomplished in three phases. The first of these concerns the building of a new gymnasium.

Mr James Taylor, Headmaster of the Hawaii Preparatory Academy, Kamuela, was introduced and asked to speak. Mr Taylor said that Hawaii Preparatory Academy also expected to erect a gymnasium. The school presently has 128 boarding students and between 30 and 40 day students. Eventually, they plan to have 300 students. It will be necessary to hold the line on enrollments due to existing facilities, and the Board will not permit the erection of shacks or temporary structures in order to accommodate more students. The school has two campuses, and this arrangement is working out very well. Transportation involves a number of types of vehicles, and Mr Taylor mentioned the various types of licensing required of the drivers.

Mr Taylor mentioned some of the problems peculiar to the school's location; at Hawaii Preparatory Academy wind drills are held. Wind breaks are under way.

Faculty has been increased, and it is planned to add slightly to that group. There will be 15 students to a class section.

"Lump thinking" is the one thing being fought this year.

The following faculty members of Iolani were introduced: The Rev Messrs: Cosby, Ward, Coon and Stretch.

The Very Rev James Cox reported next on Campaign Survey for Diocesan Status. The Dean stated there were three factors to be considered in order to obtain Diocesan Status. (1) - the Priority of Diocesan Status; (2) - the Urgency of Diocesan

san Status; and (3) - The Method by which we might obtain Diocesan Status.

Point number two was discussed first - Urgency. Morality of the situation-- at the present time we receive \$97,000 from the National Church for the Missionary District of Honolulu. All except \$5,000 goes to pay clergy salaries. Per capita income in the Islands is \$1800 per year. In a number of dioceses on the mainland this is less. We have more communicants in this Missionary Diocese than do a number of Dioceses. Yet with greater income, and more communicants, we still take nearly \$100,000 a year from the National Church. We do not take responsibility -- we expect a hand out. Therefore there is a deep emergency about this -- we can take care of ourselves.

Point number one was then discussed -- the Priority of Diocesan Status. Each church wants to seize its opportunities. If Diocesan Status is as important as we said it was (a year ago) we will undertake no major campaigns individually, we will make this cause come first.

Point number three -- Method. A sufficient sum will be required for this. The absolute minimum is \$550,000, with \$750,000 suggested and recommended. Surely it will take some scratching to raise that much. It was decided that the best time to do this would be in the Spring, in connection with the Lenten period, On Palm Sunday, 1961. An organization would have to be set up in the coming months, and work begun in the Fall of this year. About possible method of procedure -- every Episcopalian in the Islands will be asked to participate in this campaign. Have a campaign in every parish and mission. A quota can be set for every mission and parish. This should amount to about \$250,000, leaving a shortage of \$500,000. Procedure for this is to go into personal solicitation; life insurance, estates, gifts, tangible assets, etc.

Motion was made by the Dean concerning dissolution of the present committee; that another committee be appointed and look to the establishment of Diocesan Status by appointment from the Chair; that this Convocation approve 1961 as the campaign time for diocesan status, and that this fund have precedence over any other campaign.

The Dean then made the following motion:

(a) That the report of the Committee be accepted and the Committee be discharged and another Committee be appointed by the Chair to undertake a campaign for funds to establish an Endowment of the work of the Episcopate -- such fund to be in the amount of \$750,000.

(b) That this campaign be conducted in the Spring of 1961, terminating about Palm Sunday.

(c) That it is the sense of the Convocation that this campaign have priority over any other campaign being considered between the fall of 1960 and the Spring of 1961.

Motion was seconded and approved.

The Rev Dr Harry Komuro, of the Methodist Church, was introduced as a guest speaker. Dr Komuro brought greetings from Bishop Gerald Kennedy, of the Methodist Church, and from members of his Church. He spoke briefly on the Pacific Home for the Aged.

Canon Charles P Gilson, Missioner to Taiwan was introduced. He prefaced his

remarks with "it is good to be home for the first time". He brought greetings from the Church and the people of Taiwan. He spoke briefly of his work in China, and of his deep concern to return to missionary work with the people of China. Most positively he said Taiwan is not going to be taken by the Communists. These people have put down roots so deeply they can never be pushed out. The people of this island are the strongest practicing Christians in our Church. He told of the tremendous thing it is for a Chinese to become a Christian. 100 were baptized at Christmas. Taiwan now has four priests, The Rev Peyton Craighill, The Rev Mark Yung-Laing Ma, The Rev Richard S K Yoh, and The Rev Canon Charles P Gilson. Miss An-Veng Loh has charge of Christian Education, and Mrs Huang Cha E-Moh is active in the development of Woman's work and activities of the southern missions. Of the needs of Taiwan -- they need everything there is to be had, but mostly they need our prayers and interest.

Noon Day prayers were offered by the Rev Claude F Du Teil.

The Rt Rev Lewis B Whittemore, Retired Bishop of Western Michigan, was introduced. Bishop Whittemore spoke of his travels in the Far East, and very briefly concerning his present writing project about The Philippine Independent Church.

The Rev Robert Sheeran reported on Wills and Bequests. Work is being done to encourage people to take out insurance in payment of the Church. He hopes more and more will think about this most seriously. Booklets will be distributed to the clergy and lay people, setting forth the needs of our Diocese. This is actually part of the Capital Funds Campaign taking place in 1961.

The Rev Paul M Wheeler spoke briefly on our pledge of \$50,000 to CDSP. The Rev Mr Wheeler stated that this, too, has a priority, since many of the clergy of this diocese are trained at CDSP.

The Rev Canon Paul R Savanack spoke concerning the 100th Anniversary Celebration in 1962. There is to be a great opening service, somewhat like that of General Convention, with similar services on the other islands. A history of the Diocese is now being prepared. The usual convention gadgets are being considered -- plates, shields, etc. Among the prominent and international personalities being invited are the Archbishops of Canterbury and York, and various dignitaries throughout the Pacific Area, Bishops of all 8 Provinces, and guests of former Convocations, the Presiding Bishop, as well as Bishops from Australia, New Zealand, Japan, India and the Philippines.

The Rev Canon Richard Baker of Guam was introduced. Canon Baker brought greetings from St John the Divine, Agana, and spoke briefly of the work on Guam.

Mr Arthur G Smith, Chancellor of the Diocese, read amendments to the Constitution proposed at General Convention 1958 and finally to be acted upon in 1961:

To amend the second sentence of Article 1, Sec 2

To amend Article I, Sec 6

To amend Article II, Sec 2

To amend Article V, Sec 6

To amend Article X

To amend and add to Article XI

He also read the Amendment to the Book of Common Prayer Proposed at the General Convention of 1958, and to be finally acted upon at the Convention of 1961:

That the publication of a Book of Propers for the Minor Holy Days, as an alteration of the Book of Common Prayer be printed separately as a supplement to the Book of Common Prayer, embodying the proposed Propers as contained in the Prayer Book Studies XII of the Standing Liturgical Commission.

He moved that these be acted upon by Convocation. The motion was seconded by Dean Cox. A favorable vote was given for these changes.

The Rev Robert Sheeran made the following motions:

1 - That the minutes of the 58th Annual Convocation be prepared and submitted to the Ecclesiastical Authority for the District for approval.

2 - That an expression of appreciation be extended to Mrs Raymond K Hoefener for her assistance as Secretary of the Convocation and for the many hours she has given in the Diocesan Office prior to Convocation.

3 - That an expression of appreciation be extended to the Dean, Cathedral Chapter and Staff of the Cathedral Church of St Andrew for all they have done to assist with Convocation; to the Rector and Vestry of St Peter's Church for the use of the Parish Hall for the Convocation breakfast.

4 - That this 58th Convocation express appreciation to the Rt Rev James A Pike for his presence at our Convocation and for the inspiration he has brought to us as our Convocation guest, and that appreciation is also expressed to The Rev Canon Gilson and the Rev Canon Richard H Baker for the pleasure they have brought us in being present for our Convocation.

Mr Arthur Smith asked that an expression of appreciation also be included for Bishop Whittmore.

Motions were seconded and passed.

Benediction was given by the Bishop, and meeting adjourned at 12:55 PM.

#### REPORT OF THE DEPARTMENT OF MISSIONS AND CHURCH EXTENSION

The Department takes pleasure in reporting the following achievements in 1959:

Church services have been held this year by either the Bishop or clergy from the District on American Samoa, Wake, Midway, Kwajalein and Christmas Island.

Services for the members of the Philippine Independent Church have been held each Sunday in Parke Chapel, St Andrew's Cathedral, by the Rev Timoteo P

Quintero, who came from the Philippines in August. He holds the services in the Ilacono Dialect. He has a regular schedule for visiting the neighbor islands for services.

Additions and improvements during the year are:

CALVARY CHURCH, KANEOHE - new church and furnishings at a cost of \$75,000.

EPIPHANY CHURCH, HONOLULU - New Educational Unit and offices; extension of the Church building; new chancel and undercroft; ten new pews, \$105,000.

HOLY TRINITY, HONOLULU - New Parish Hall started, estimated cost \$47,300.

HOLY NATIVITY, AINA HAINA - Stone wall enclosing patio of the Youth Center, \$3,720.80; revision of classrooms, \$2,444.00.

HAWAII PREPARATORY ACADEMY, KAMUELA, HAWAII three dormitories on the new site, including a kitchen and dining room, \$300,000.

IOLANI SCHOOL, HONOLULU - Student Union Building with cafeteria, teachers' lounge and Common Room, \$137,680. Equipment for same \$50,000.

ST ANDREW'S CATHEDRAL - Grounds-landscaping and trees, \$2,000; Grounds, walks and driveways, \$4,000; Cathedral, carving of Capitals, \$330; Davies Hall, waterproofing walls, \$2,000; Repairs to Davies Hall, Deanery, Tenney Hall, Cathedral Pews, Flood Lights, etc, \$1,670.39.

REPORT OF THE EPISCOPAL CHURCHWOMEN OF HAWAII

With the faithful and devoted efforts of the executive board, the whole-hearted cooperation of all the branches, and the inspirational guidance of our beloved Bishop, the Episcopal Churchwomen of Hawaii have made significant advances in all areas of their work during 1959.

Special prayers and meditations set the tone for all monthly board meetings and interesting and stimulating programs were arranged by the Christian Education Secretary to highlight our interests for the year. Mrs Mary Lou Turner spoke on the Youth of the Church. Miss Mary Catton and Mr Oscar Fulford brought brief messages about "Pohai Nani", the proposed home for the aged. A colorful description of Seabury House, accompanied by a series of slides, was presented by Mrs C Montague Cooke bringing new understanding of this National Conference Center. Miss Herbert, a missionary serving in the Philippines, spoke briefly of her work in St Luke's Hospital, Manila, P I, and described St Theodore's Hospital, which will be the recipient of our 1960 supply assignment. Bishop Kennedy reviewed his annual trip to the Far East in the spring, and his trip to the mainland in the fall. We were especially happy to have representatives from Hawaii, Kauai and Maui attend the November board meeting. It is hoped that the vigorous discussion and exchange of ideas that took place following the meeting, will be of benefit to the work of the women on all islands. A motion in the form of a resolution, appointing Mrs William Fraser as an Honorary Member of the Episcopal Churchwomen of Hawaii executive board, was made and carried at the June meeting. We are proud to have this devoted woman serving on the board.

The Transfiguration Mission in Yauco, Puerto Rico was our national supply assignment for 1959. As in the past, the women gathered five Fridays during Lent to work on the assignment which totaled 888 infants garments. A letter from the Reverend Victor Burset, Vicar of the mission, describing in detail this struggling little mission that is situated in the heart of the coffee country, made our Lenten sewing project all the more meaningful. Mrs Richard Steere, a former resident of Puerto Rico, gave an interesting talk on her impressions of Puerto Rico. A travel film, depicting the more glamorous area of Puerto Rico was also shown to the women. Our Lenten study also included the Middle East. Mrs George Kellerman reviewed Denis Baly's book "Multitudes in the Valley" and Miss Margaret Monteiro gave a report on John Badeau's book "The Lands Between". Both of these books were recommended by National Council. A light lunch was served by several of our branches to the men and women of all denominations who attended the Lenten noonday prayers each Friday. Devotions and meditations were prepared by several women under the direction of the Devotional Chairman for the Lenten Chain of Prayer which is held each year in conjunction with the Lenten sewing project. A worship handbook published by Christ Church, Michigan, has been distributed to all branches for use in their individual meetings. We were privileged to have Dr Gladys Falshaw conduct a "Quiet Day" for the women of the diocese during her recent visit to Honolulu. Many of the parishes and missions are including "quiet days" in their yearly programs, and many more of the churches have formed Prayer groups and Bible study groups.

The District Altar Guild conducted workshops for several of the Churches and one for teenage girls at the camp at Mokuleia. Twenty-three missions and two parishes were furnished with Altar linens during the year. A gift of purificators to a Church in Ontario, Canada was thoughtfully acknowledged by a gift of Irish linen.

Support of the Church Periodical Club enabled the women to send a set of the Interpreter's Bible to Bishop Cabanban of the Philippines, seven gift subscriptions of the Living Church to members of the clergy, books to eleven seminarians, and contributions to the National Book Fund and Provincial Church Periodical Club.

For the first time in history, all but one branch submitted the number of contributors to the United Thank Offering. Although the amount contributed during the year totaled an encouraging \$5,951.02, we now know that only 25% of our women are sharing their daily blessings with others. The United Thank Offering Secretary is doing a tremendous job and has been ably assisted by Miss Margaret Monteiro. As a team, they have toured the "circuit" and spread the word about the UTO. However, greater support is necessary if we are to grow in this endeavor.

We continue to be proud of Mrs Henry Caldwell for her fine and capable leadership of the United Churchwomen of Honolulu. She has been instrumental in forming a State board for this ecumenical group which encompasses all islands, and serves as its leader. Our women participated in the World Day of Prayer and World Community Day. St Andrew's Cathedral was host for the May Fellowship luncheon and those who were fortunate enough to attend shall long remember Governor William F Quinn's stirring address on the theme, "How Much is Enough?"

During the year, the women have responded to the needs of the community through their service to the hospitals, State institutions, Armed Forces YMCA, Oahu Tuberculosis and Health Association, cooperated in all National fund drives at the State level, and responded to the United Clothing Appeal sponsored by the diocese. An eight hour Civil Defense course on "Preparation for Survival" was attended by representatives of many of the branches on Oahu. Mrs Joseph Lucas has been

working closely with the CD authorities and we are grateful to her for the magnificent job she did in conducting this course for our women. Those who took the course passed the final test with flying colors due to her excellent tutelage.

Voluntary contributions from the branches during 1959 were forwarded to the following: Canterbury House, St Michael's Cathedral, Japan, Church Divinity School of the Pacific, St Margaret's House, and included a Christmas check to Taiwan and assistance in providing a special Thanksgiving dinner for Armed Forces personnel. The women's "Specials" included the Bishop's Discretionary Fund, Seminary Student Fund, Kauai Missions and St James Mission, Kamuela, Hawaii. These specials, presented by Bishop Kennedy and members of the clergy, will long be remembered as a highlight of the 57th annual meeting. \$5,377.50 was pledged by the branches as well as individuals to these most worthy projects.

It is thrilling to look back and recall all the events that transpired during the year, and the distinguished speakers that literally brought messages from all corners of the world. Monthly, island-wide meetings, inspired by our Bishop, were designed for inter-Church fellowship, and the opportunity to broaden our Church's witness to the community and to the world through carefully planned programs. These monthly meetings were scheduled for the third Thursday of each month, but a certain amount of flexibility was necessary in order that we could take advantage of outstanding speakers passing through Honolulu.

The initial gathering began, quite fittingly, with a reception for Mrs Arthur M Sherman, Executive Director of the General Division of Women's Work (now retired) at Holy Nativity. Mrs Sherman brought us a first hand report of the 100th anniversary celebration of the Nippon Seikokai, the Episcopal Church in Japan. An over-due plane bearing our guest speaker for May, Bishop Ogilby of the Philippines, caused a last minute change in plans, but we were rewarded by hearing the Rev Paul Wheeler, Rector of St Clement's Church, speak on the tremendous task being done by the Hawaii Association for Retarded Children. St George's hosted this meeting and climaxed the day with a tour of Pearl Harbor. In June we had the pleasure of visiting Epiphany Church.

After a tour of their fine new education building, we settled down to hear Mr Edward Schuck, U S State Department representative speak on the work being done by the State Department in establishing "good neighbor" relations with visitors from foreign lands who pass through Honolulu. A spirited question and answer period brought much enlightenment to those who attended.

The Rt Rev John Bentley, Vice President of National Council and Director of Overseas Dept, spoke to the women in September on the work of the Church throughout the world. We also had the pleasure of having Mrs Sherman Johnson, wife of the Dean of CDSP, with us for this meeting at St Mary's Mission. In October the women travelled to Calvary Church in Kaneohe. All reports indicate that this was a fun and frolic day. Bishop Kirchhoffer was the guest speaker on this occasion. St Peter's Church was host for the November meeting. The Rev Burton A MacLean, newly ordained Deacon, and Headmaster of Iolani, spoke on Christian Education in the parochial schools. The island-wide meetings for 1959 ended in December with a "Quiet Morning" conducted by the Rev William Grosh, Vicar of Calvary Church. Mr Grosh, who is Director of Christian Social Relations for the diocese, presented three meditations based on the Christian Family in Contemporary Society. St Stephen's, Wahiawa, was our host on this occasion. All who have participated in these events have enjoyed the fellowship of their diocesan family and have most



certainly broadened their knowledge of the whole Church. We are ever grateful to Bishop Kennedy for inspiring these events and for the active part he took in all gatherings. Our sincere thanks go, also, to the members of the clergy who participated.

It has been a great privilege and a truly joyous experience serving as the president of the Episcopal Churchwomen during the past six years.

Tonight we welcome the Bishop of California, The Rt Rev James A Pike, D D, as our guest. We are indeed grateful to him for giving us this time out of his busy and pressing life. He honors us with his presence.

It is a real joy to also have as our guest, the Rt Rev Lewis B Whittemore, Retired Bishop of Western Michigan, who is visiting Honolulu after a tour in the Far East.

We welcome, for the first time, Canon Charles Gilson, from Taiwan, who has been serving so faithfully in the name of our Church, and Canon Richard H Baker, from Guam.

We come together tonight in the 58th yearly meeting of our Church Legislature in the 98th year of our ministry in Hawaii.

I think tonight of the great company which we are privileged to represent: 18,166 Baptized Members, 40 Congregations, and 42 active Priests in our Diocese. Most of these Communicants I have confirmed myself (10,206). These have been happy years of remarkable growth. It was my good fortune to come to Hawaii when the stage was set for a great advance. In 1959 we had 707 Confirmations and 762 Baptisms. We must be ready to keep moving forward in our relentless mission.

Since our last Convocation we have lost 5 clergy by transfer to other dioceses.

We now have 62 clergy, including active, retired, non-parochial and chaplaincies.

I am indeed grateful for the clergy who have come to serve the parishes and missions in this District since I became bishop. Only one priest who was here when I came, is still in the active ministry in the Diocese - Canon Shim. I rejoice also that the clergy who stay in Hawaii and in their congregations for a reasonable

time give our people confidence in the development of the Church, and of the care and cure of souls.

## DIOCESAN STATUS

Time is drawing closer to 1962 when we commemorate our 100th Anniversary, at which time we desire to achieve Diocesan Status, if possible.

This can mean much to the life of our Church in this new state and it will give us standing in the eyes of the whole Church. It will release Missionary funds for God's work elsewhere. However, it will mean hard work, great sacrifice, sound planning, and above all a deep faith.

We will have to mobilize all the manpower of our Church in Hawaii and before God's altar dedicate that power to an unselfish devotion to achieve this goal. I believe God is calling the Episcopalians of our Diocese to meet this challenge.

It is most urgent that this District become a self-supporting Diocese. However, it is better to have a strong Missionary District than a weak Diocese. At the Convocation last year the first firm move was taken toward this goal, even though our first step toward self-support was taken in 1955, when we advised the National Council that we would be responsible for the Bishop's salary, and since then we have assumed responsibility for \$5,000 of our Office Operating Expenses, full support of Staff Clerical Salaries, and Bishop's allowances and Pension.

Local missions are now paying \$36,381.66 toward clergy salaries, relieving the National Church of this amount, as well as assuming their local operating expenses for utilities, travel, auto, Church School, etc.

We have spent \$958,280.00 this past year in building and expansion programs. We have a building indebtedness in the Diocese as of January 1, 1960, of \$630,420.03. New loans in 1959 amounted to \$273,554.21. We paid off \$210,288.54 during the same period.

Those who live close to our finances realize the need for a campaign for Capital Funds to advance our Church. We are far behind what we should be doing in expansion work in Hawaii for Christ and His Church. We need cash and clergy and lay Leaders to do the job.

The last General Convention took important action that will vastly strengthen the Church. After passing resolutions for considerably increased national budgets, it voted "that all members of the Church practice tithing as a basic Christian responsibility, and commend to all vestries the goal of giving one-half of the ordinary income of their parishes to work outside of their parishes on the National, Diocesan and Local programs."

What it could mean if the Board of Directors of the Diocese, and if a vestry would sit down to determine how best to get resources and use those resources for the welfare of the whole Church and the Community, instead of thinking only of light bills, grounds, upkeep, cleaning bills, telephone, water and other local expenses.

We believe that the Church was created by our Lord for the primary purpose of proclaiming the Gospel to the World. The only way as Church members we can fulfill Christ's purpose is to accept the fact that the Church exists not for our benefit, but to tell those outside the Church the Good News about Jesus Christ.

## MINISTRY OF THE LAITY

I think not only of our Diocesan Staff, but our Chancellor, Arthur G Smith; Finance Chairman, Herman V von Holt; Keyman, Arthur Caswell; President of the Diocesan Women, Mrs George Goss. The Rev Fletcher Howe, for his work on the History of the Diocese. I think as well of the great company of those in our congregations - the Church School leaders, choir singers, women's groups, E M C Workers, Vestries and Bishop's Committees, acolytes, janitors, Madonnas of Church Kitchens, who serve meals -- there is a unique and wonderful partnership of the men and women together in Christ's Church, that is a never ending source of thanksgiving for all of us.

There is no easy way of being an Episcopalian in Hawaii. There are always building and expansion programs, budgets to be raised, and missionaries to be supported. We will never see an end to this.

There is no easy way to be an Episcopalian in the National Church. There are seminaries to support, there are Domestic and Overseas Missions, and Missionaries counting on our backing.

There is no easy way to be a Good Citizen. We need schools, industries, libraries, homes, public buildings, highways -- we need most things that many people take for granted.

I thank God that our Church is taking her rightful part in this -- not just in terms of buildings, but in terms of positive social leadership of clergy and laity alike, who are not afraid to speak for the truth and for the future, who work for Community and State benefit.

We must constantly remind ourselves that the Church is no static, fixed body, but a constantly expanding new frontier, and that our task of witness and teaching and welcoming new members into our household is a never ending one.

How often individual Christians imagine they are doing God a service when they go to Church -- as if attendance at public worship were the end instead of the beginning of our Christian living.

We make a terrible mistake in looking at what We are and what We have done, rather than what Christ has Sent us to do.

## REPORT ON SPECIAL FIELDS

### SAMOA

The Bishop visited Pago Pago in American Samoa, and arranged for services. It is our plan to send one of our clergy from Hawaii to Samoa every two months to minister to our people. The lay people have started a Sunday School and a lay reader will assist with services.

### TAIWAN

We will have the privilege of hearing from Canon Gilson on the work of our Church in Taiwan. I would take nothing from this thrilling report, but I do wish to tell you how much his leadership, with that of Mrs Gilson's, has meant to our people and the Church. He has my full confidence and admiration; the Chinese people are devoted to him.

The Rev Robert Stretch of Iolani has assisted the Bishop by taking services in Midway and Kwajalein, and by bringing Communion to our people on these islands, for which we are most grateful.

#### CHRISTMAS ISLAND

At the request of the Church of England and the Royal Air Force, the Bishop visited Christmas Island for Confirmations and during the illness of their Chaplain, three of our clergy, Kenneth Cosbey, Iver Torgerson and Paul Savanack have visited the island to conduct services.

#### INSTITUTIONS

Our Schools - St Andrew's Priory, Iolani, the Academy, as well as our parochial schools, are experiencing the embarrassment of success by not being large enough to accommodate all who wish to attend. We are grateful to our school leaders and commend their reports to your careful study. We will hear from Sister Evelyn, Headmaster James Taylor, and The Rev Burton A MacLean, tomorrow.

Canterbury House -- Diocesan Armed Forces Center, and our three Conference Centers, are places of much activity, filling their responsibility and obligation to our Youth and Children. We wish to thank the Rev Richard Humke for his work at the University of Hawaii, and Mrs Thomas Aaron for her work with our Armed Forces.

Our summer camps on all islands are increasing in popularity, and the leaders are to be praised for sacrificing their time and sharing their talents in these projects. Their reports will be presented tomorrow. The leader in charge of Mokualeia Conference Center this past summer was Miss Cornelia Ransom. We are fortunate to have a laywoman of our Diocese give her services for this important task.

#### GUAM - OKINAWA

Canon Richard Baker is with us this year. Work is progressing on Guam, and ground has been broken for their first permanent building, which will be a parish house and education building. We will await his report tomorrow with great anticipation.

We regret that Canon William Heffner will not be present. The need for more clergy is our big problem, and keeps us from opening new mission work, where the need for the Church is great and where the opportunity awaits our establishment of missions, schools, clinics and university work.

#### WORK AMONG OUR FILIPINO PEOPLE

Last year one of our objectives was to have a worker to minister to our citizens from the Philippines. God has answered our prayers in the person of The Rev Timoteo Quintero, who was sent to us by the Philippine Independent Church. He has contacted thousands of members of the Church and is holding services on Oahu, Maui, Hawaii, and Kauai. He is one of the busiest clergy in the Diocese and the response to his faithful and devoted ministry has been most encouraging.

We are pleased with our men who are Postulants and Candidates for the ministry from our new state. Men of various cultures and races; men who know the Islands and our People. We now have 11 young men from our islands studying for the ministry and 8 more in college, who are postulants, expecting to enter Theological Seminaries in the near future. They need help with the expenses of their training. After 4 years of college, most families are not in a position financially, to send their sons for 3 years more of Theological Training. This should be the responsibility of the Diocese.

I pray God daily to guide us in Hawaii in our plans for our Churches' Advance and Development program that we may have the material we sorely need. I pray God daily that He will call our finest men into His service in the Sacred Ministry. But most of all I pray God that He will keep a burning sense of Mission in our hearts.

#### OBJECTIVES - 1960

1. The Bishop's Men. The Bishop to appoint a group of laymen who will visit a different mission each Sunday. They will meet with the Vicar and people, especially the Bishop's Committee. They are to inquire into the needs, problems, and opportunities that face the mission, then make a study of their findings and suggest ways and means by which help can be given.
2. Arrange to employ a Diocesan Director of Christian Education -- one who is especially trained for this position, so that assistance may be given to all our islands. Have the Department of Christian Education make a study and report on steps to be taken, at an early date.
3. Lay Evangelism. We are not accepting our responsibility to bring others to Christ as we should. Every congregation must justify its place in the Church by the witness it bears and the people who are won. Statistics are not the only media by which to judge the life of a congregation, but statistics are an indication of something that is or is not happening. This means more baptisms and confirmations.
4. One Hundredth Anniversary in 1962. During this year the Committee appointed in 1959, must step up its plans, enlarge its membership, and report regularly to our congregations. Let us take the reports from this Convocation concerning our plans for the Anniversary and have them read or published in every congregation to prepare and keep our people informed.  
  
This should be a year long celebration -- not looking backward to our achievements, but forward to our possibilities. We have many distinguished friends of the Church throughout the world who are looking forward to being with us in 1962.
5. Plans for Diocesan Advance and Development Fund. This Committee will ask for the support of our lay experts on finances, and take immediate steps to crystallize our plans for this important endeavor.

REPORT OF ST ANDREW'S PRIORY - 1959

ENROLLMENT

Since our annual report covers two academic years, we give our comparative enrollment for the last half of the school year '58 - '59 and the first half of the current school year. In our last report we claimed to have a capacity enrollment, but we have found out since then just how expandable a classroom can be. It will be noted that the increased enrollment has come in the upper grades of the school. The school is becoming increasingly in favor with the parents in the armed services, and presently over 18 percent of the current enrollment comes from this group.

GRADUATES

On June 2, 1959 42 girls were graduated from the school. Of these 39 continuing their education at college, nursing school or business school. Two are employed and one has married. Two of these girls now attending the University of Hawaii were selected for an accelerated work program. They are Eunice Au and Loretta Pang.

The school clerk who is a licensed practical nurse also doubles as the school nurse.

RELIGIOUS EDUCATION

Teaching of the Christian faith and training in the life of God's Church continue to be integral parts of the school curriculum and are recognized as such. At the

beginning of this school year The Rev Robert Sheeran took over the duties of school chaplain. These duties include teaching, counselling and the responsibility for the daily Chapel services. Sixty-three percent of the student body has been baptized, and 28 percent has been confirmed. For a year now we have tried the experiment of referring all requests for baptism and confirmation to the clergy of the parishes and missions. The difference between the number of confirmed in the previous year over the current year undoubtedly reflects this. There has been a decrease of 5 percent in the number of confirmed students in the school. There has been an increase of 2 percent in the number of baptized. Perhaps one year is too short a time in which to test this policy.

GENERAL REMARKS

Students at the Priory are encouraged to develop to their highest potential in every area of ability. Two members of the senior class, Gail Kirgis and Mavis Kobayashi, received Letters of Commendation showing that they had ranked just below the semi-finalists in the National Merit Scholarship Qualifying Examination. Between 85 to 90 percent of our graduates continue their education in colleges and technical schools throughout the country. Several of these are presently studying under competitive scholarship grants on both the graduate and under-graduate levels.

Following a year of experimentation both Latin and French have been added to the seventh and eighth grade curriculum. We have returned to the four-year sequence of history courses on the high school level.

Another senior, Diane Chang, won a trip to the mainland in a 4-H competition in the field of homemaking. This marked her second 4-H award in two years. The Priory year book KA ALELE was awarded the ALL AMERICAN rating by the National Scholastic Press Association for 1959. The Priory was the only school in the state of Hawaii to receive this highest of five ratings for the year.

Music appreciation and creative art at all levels, and choral music in the upper school are stressed both for their cultural content and in an effort to foster or develop latent talent in these fields.

It is kept before the minds of the students that the aim of the school is to train them for that Christian womanhood that will give useful service in home, Church and civic community. This is done by encouraging and making it possible for the student body as a whole, as well as groups and individuals, to take an active part in service projects for the school, the Church and the community. There is a strong temptation to all who live here surrounded by the ocean on all sides to become insular in outlook in spite of the advantages of being the "crossroads of the Pacific" and now the fiftieth state in the Union. Therefore a part of the service program of the school is to stimulate a genuine interest in the needs of people in other areas. This has been done in a variety of ways this year, chief of them being through the sending of CARE packages, and donations to a Christian Arab Hospital in the Holy Land serving the refugee population.

BENEFACTORS

The local chapter of the Associates of the Transfiguration raised \$445.00 for the support of the scholarship they maintain at the Priory. Individual donors have given both to the building fund and for specific needs in the line of equipment.

CURRENT NEEDS

Our debt has been reduced to \$7,318.67, so we are giving consideration to our next building project. We have a chapel fund started, however not only money but land is needed for this building. More and more we realize the loss to both the school and to individuals in not having a chapel on the school campus large enough to accomodate an entire class at a time, if necessary. The present tiny Oratory leaves much to be desired both as to size and opportunity for quiet retirement.

We must increase the salaries of our teachers. This will be done by raising our tuition rate for the next school year.

It is also necessary that we provide a more adequate art room for the school. In this the termites are giving substantial assistance by their gradual demolition of the present one.

ACKNOWLEDGEMENTS

We wish to express our grateful appreciation to the Bishop and the Diocesan Office workers who throughout the year have aided and supported us in our work, as well as to Dean Cox and the Cathedral staff who have graciously and cheerfully come to our assistance on numerous occasions and borne patiently with our impurities. Our gratitude also goes to Canon Paul R Savanack, The Rev Shelton Hale Bishop, and The Rev George H Quarterman, Jr for taking classes in religion in the school to help out in an emergency.

IOLANI SCHOOL

REPORT OF THE HEADMASTER  
June 17, 1959 - February 1, 1960

Iolani is dedicated to the goal of giving to her 963 boys the finest possible preparation for college, for life, and for leadership in Church and Country. To achieve this, the School is committed to standards of academic and moral excellence, which rests squarely on a Christian foundation, following the tradition and practice of the Episcopal Church.

Academic excellence cannot be achieved without moral excellence. Academic achievements have their roots in the honest mind. The honest mind can be

cultivated only in morality, and morality has its sure roots in the Christian faith. It is our Faith, symbolized in our Chapel services, taught in the courses in Religion, and practiced in our daily lives, that the source for moral strength is found. Moral excellence is the certain foundation for academic excellence. Therefore, St Alban's Chapel is central to our way of life.

#### THE FACULTY

The School has strengthened and added to the faculty. Seven of our faculty, after faithfully serving Iolani for a total of twelve years, retired or accepted new positions. We lost from our roster, T S Applegate, Charles Edwards, Dr Shunji Nishi, Ernest Villers, Martha DuBose, Harriet Lichty, Vera Day, and Mrs Charles Alkire.

Twelve new faculty members have been appointed:

Mrs Robert Brown, the wife of a University professor, and a graduate of Western Washington with a degree in music, teaches music in the upper grades of the Lower School, and chorus in the Upper School.

Mr Robert S Burdick, (Captain, U S N ret) is a graduate of the Naval Academy, and Massachusetts Institute Technology, where he had a distinguished career. He is retired "young" from the Navy and is teaching the advanced placement course in mathematics.

Mrs Jeane Chun, a teacher in the D P I for the past two years, is teaching first grade.

The Rev Kenneth T Cosbey, for the past number of years, Rector at St John's By-the-Sea, is the School Chaplain, and Priest-in-Charge of St Alban's Mission.

Mr William H Kleyboecker, a former Iolani master, returned this Fall as instructor in physics and chairman of the Science Department.

Mrs Charles Lamoureux, a graduate of Rhode Island State University and the wife of a University professor, teaches fifth grade.

Mr Paul L Lynch is from Massachusetts, graduated from Yale in June, and was Yale's football captain. At Iolani he teaches English and coaches football and is class adviser to the ninth grade.

Mr Thornton W Moore, a graduate of the University of Maine has been instructor at the Catlin School for the last six years. He teaches a sixth grade.

Mrs Marion Pawlovich, a graduate of the University of Saskatchewan, teaches a fourth grade.

Mr John Somerville graduated from Yale two years ago, where he had a fine academic record. He teaches history and Latin, coaches the tennis team, and is a faculty advisor to the school year book.

Mr Reed Taylor, another graduate of Yale joined the English department. A native of Wisconsin, he is interested in publications, singing, and dramatics. He is also advisor to the school newspaper and a coach for the school play.

Miss Hedwig Zorb, with a fine educational background of teaching and administration in a Church school, teaches the upper courses in mathematics at Iolani.

Mrs Charles Alkire, although officially retired, returned to Iolani as a part-time instructor in music at the Lower School, grades kindergarten through third.

I regret, that for reasons of health, Mr Leslie Kittle, in charge of music at Iolani has been forced to take a leave of absence for the second semester. We hope Mr Kittle will return to our faculty next fall.

The faculty-student ratio, with the five faculty additions, this year, is 1-23. Such a ratio, although not ideal, does permit personal attention to the boys' individual development. Iolani will add five instructors for 1960-61, bringing the classroom ratio to 1-20. This will allow even closer faculty supervision of our boys' study program, in preparing them for college. Since Iolani is a boys' school, new faculty appointments in the Upper School (grades 7-12) will be men. The school has adopted the policy of teacher-coach in athletics, wherever possible. New men instructors are given coaching assignments.

#### FACULTY SALARIES AND PREREQUISITES

In order to attract and retain the ablest teachers Iolani has instituted a new salary scale which is equal to public and other private schools in the State. In addition, through the generous gift of a member of the Board of Governors, Iolani is establishing a long over due retirement program for faculty and staff, a term insurance program, and a hospitalization and medical plan. Travel allowances for new teachers has been increased, and a policy for sabbaticals instituted. Given the present attractions of teaching at Iolani, these additional benefits place Iolani in an excellent position to secure and hold the finest faculty.

#### TUITION INCREASE FOR 1960 - 1961

Because of the school's determination to have an outstanding faculty, properly compensated, the Board of Governors voted to increase the tuition for 1960-1961, to meet the anticipated increase in the cost of operation. These increases have been interpreted carefully to Iolani parents, and demand for admission to the School in 1960-1961 has noticeably increased.

#### NEW FACULTY APARTMENTS

In April 1959, the Board voted to close Iolani's small boarding department, because of the greatly increased demand for a day school. This past summer the dormitory was converted into six much needed faculty apartments, increasing our total number of apartments to twenty-eight. These are desirable facilities, especially in the light of Honolulu's critical housing shortage.

#### DEVELOPMENT PROGRAM AND IOLANI CENTURY FUND

One of the Board's major decisions this year was that of instituting a development program for the School. Under the chairmanship of Mr George Sumner, the Development Committee is charged with long range planning. The Committee has recommended, in order of priority, the building of a new gymnasium, and addition for the Upper School (to include an enlarged library and science rooms, study hall, and classrooms), and a new building for grades three through six.

The Board has approved the plan, and an Iolani Century Fund Committee has been appointed to raise the necessary amount for the new gymnasium. Clesson Chikasuye is Chairman, assisted by Chinn Ho and Henry Walker as Vice Chairmen.

Iolani's Board of Governors, devoted and hard working, meets monthly, and is committed to provide the best possible environment for educating our boys.

#### ADMINISTRATIVE CHANGES

In order to bring more careful planning into the daily operation of the school, certain administrative changes have been made. The post of "principal" has been eliminated. The duties of the administrative staff have been redefined. The Headmaster is the chief academic officer of the School as well as administrative head. The posts of Director of Studies for the Upper and the Lower Schools have been created.

Mr Paul Simpson, Assistant Headmaster, is Director of Studies for the Upper School and Miss Louise Baack for the Lower School. The Rev David P Coon continues as Director of Admissions and College Counsellor and has, with his registrar duties, taken on the added responsibility for permissions and discipline. A new post, Director of Information, has been created and is presently filled by James H Pott. His responsibilities are to assist the Headmaster in the fields of alumni relations, public relations, and school development. This post has already proven its value in creating a new school catalogue to be published soon; sending a questionnaire survey to Iolani Alumni with the intention of bringing our Alumni into close and active relationship with the School; planning the publishing of a regular Iolani Bulletin which will be sent quarterly to Alumni, parents and friends; and establishing an excellent rapport with the local press. Other administrative changes include the appointments of Department Chairmen, a school Bursar, Cashier, and a new plant Foreman under the supervision of the Superintendent of Grounds and Buildings.

#### CURRICULUM

The Department Chairmen, Director of Studies for the Upper and Lower Schools, and the Headmaster have made a careful study and revision of the School's curriculum. The demand for better prepared boys has guided us in devising a curriculum in which Iolani courses of study are a year advanced over comparable public and private schools. Wherever it is deemed academically advisable, in the judgement of the faculty and Director of Studies, boys will be encouraged to take

five solid courses in the Upper School - in English, mathematics, history, language, and science. Three years of a foreign language are declared a minimum, as well as three years of science. Advanced Standing courses are presently offered in mathematics, and will be introduced in the other solid subjects.

This year, for the first time, academic probation has been established. This has been done to insure the maintaining of high academic standards.

#### ADMISSIONS

Iolani's enrollment is currently 963 boys, from kindergarten through the twelfth grade. The enrollment by grade is as follows:

The Upper School is approximately, and by intention, twice the size of the Lower School.

The policy of the School is to admit boys with sound character and the promise of ability, regardless of racial background or social position. Iolani seeks to represent the best in our youth from the State of Hawaii.

All candidates and parents are interviewed and the boys tested. Our experience this year indicates a sharply increased demand for admissions. Unfortunately, because the school is limited in its physical size, many boys who apply cannot be accepted. The positive result of this inevitable selectivity is that the academic achievement of the boys has reached new heights. Iolani, in its Educational Records Bureau testing this year, stands somewhat higher than the other private schools in the United States and considerably higher than the public schools. Because of the increased demand in admissions, Iolani may in the fairly near future, have to give consideration to a modest expansion to its enrollment.

In order to aid able boys of modest circumstances the School has increased the amount of its financial assistance program. It is the strong desire of the Headmaster to expand this aid, since God-given ability is often a stranger to economic circumstances.

#### COLLEGE ADMISSIONS

All eighty-eight graduates of the class of 1959 were accepted in college. The careful program of counselling our seniors for college is progressing on schedule. More seniors are applying to mainland colleges than ever before.

#### STUDENT LIFE

Iolani has for the first time in its history, the office of Senior Prefect. Ten outstanding boys of proven leadership meet weekly with the Headmaster to plan and guide school activities. Acknowledged by the boys as the leaders of the school,

the Prefects have a profound beneficial influence on behaviour, academic standing, manners, and dress. The Prefects are Stanley S Inkyo, Robert N Asato, Stanley Kanetake, Ronald Hayashida, Kenneth Nishikawa, Wayne Kawamura, William Madden, William Matsuura, Frederick Sakamoto and Alvin Yamashiro.

Student participation in athletics, extra curricular and social activities is enthusiastic. Half the size of the next smallest school engaging in all major sport competitions, Iolani's teams have turned in creditable performances. The school newspaper, Imua, maintains a high standard of journalistic excellence, and a position of leadership in student thinking.

#### PARENTS

The parents of Iolani have demonstrated their loyalty and interest in the School through active participation in the Parent Teacher Groups and in their devoted efforts to bring off successful carnivals and building campaigns in the past. This year parents have contributed a new piano and water fountains to the Lower School, and a sum of money for a new language laboratory for the Upper School.

#### BUILDINGS AND GROUNDS

The Student Center is an excellent new building. Put to the test of use this year, it has proven completely successful. Meals have become an attractive part of our common life. Manners and conversation have been enhanced with faculty at tables with students. K C Lau, the new cafeteria manager, and his assistants has succeeded in pleasing the palate of the boys insofar as they ever can be pleased.

Throughout the grounds, Kenneth Okano, Supt of Buildings and Grounds, and his staff, have with the cooperation of the faculty and boys enhanced the care and beauty of the property. The Board of Governors has approved further needed improvements in a new planned front entrance on Kamoku Street, and improvements along the boarders of the School's property.

#### OUR CENTENNIAL

The finest means for celebrating the hundredth year of Iolani in 1962 is in the hands of the whole Iolani family and the friends of the school throughout the State, as we turn our efforts to back the Iolani Century Fund when it launches its campaign to build a finer school for Iolani boys.

#### IN CONCLUSION

The Headmaster and his wife and family are deeply grateful for the warm aloha we have been given. I am indebted to our Bishop and members of the Board of Governors for their unceasing and devoted help and support; to our faculty, administration and staff for their willing, loyal cooperation, and untiring efforts to give our boys the best education; and to our boys who have opened their warm hearts in loyal support and who have won my devotion and admiration. This report would not be complete without telling of my thanks to my predecessor, Frederick A McDonald, who cheerfully gave of his time and excellent advice last Spring to "fill me in" and to Bing Fai Lau, longest at Iolani, who, seeing Headmasters come and go, said "I think you should stay!" It is a joy to be at Iolani, and to play some small part in

educating our boys in academic and moral excellence in preparation for college and for life.

#### The Report of the President of the Board of Governors

The Rev Canon Frederick A McDonald, Rector and Headmaster, resigned as of March 13, 1959 to take a position with the National Council of the Episcopal Church.

The Board of Governors Special Committee, appointed to secure a new headmaster, was very fortunate to have found the Rev Burton A MacLean to fill this important position in the life of our Church and the School.

The Rev Mr MacLean comes to Iolani from Yale University, where he was Associate University Chaplain and General Secretary of Dwight Hall. He received his B A degree from Yale in 1938, where he was an English major. As an undergraduate he was a member of the Varsity crew, President of the Yale Glee Club and a member of the Whiffenpoofs. In 1942 he received a Bachelor of Divinity degree from the Yale Divinity School.

The Rev Mr MacLean was a United States Army Chaplain from 1944 to 1946, serving in Europe and Japan. In 1946 he became Assistant Dean of Chapel and Director of Undergraduate Religious Activities of Princeton University.

He arrived in Honolulu on June 17, 1959 with his wife, Catharine, and their six sons, Burton, Jr., John, Thomas, Peter, Henry and Robert and their daughters Katharine and Mary.

We feel very fortunate to have a man of his caliber and experience as head of Iolani School. His leadership was immediately accepted by students and faculty, so that many advances have been made in the academic standing, as well as the physical improvements of the school.

The Board of Governors joins with others in extending our sincere Aloha to the whole MacLean family.

During the interim period a Special Committee was appointed to carry on the administration of the School. We are all deeply grateful to Mr James Pott, Chairman, Dr Shunji F Nishi, former Chaplain, Mr Paul Simpson, Director of Studies of the Upper School and Mr Arthur Robertson, former Director of Studies of the Lower School, for the leadership they gave Iolani during the period when we were without a Headmaster.

## IOLANI SCHOOL

### Report of the Interim Committee

The Rev Canon Frederick A McDonald resigned from his office as Rector of Iolani School in order to accept the appointment to his new post as Representative of the Armed Forces Division of the National Council in Europe, and left the School on March 13. Bishop Kennedy then appointed an administration committee of four members of the faculty, consisting of James H Pott, Chairman; Paul M Simpson, Principal, Upper School; The Rev Shunji Nishi, Chaplain; and Arthur Robertson, Principal, Lower School; to serve as the Interim Committee for the balance of the school year.

On March 17, the Board of Governors of Iolani School appointed The Rev Burton A MacLean, Headmaster of Iolani School. Mr MacLean arrived at Iolani April 12, for a week's visit in order to meet the Board, acquaint himself with members of the faculty and familiarize himself with problems facing the School.

On May 10, the dedication of the Student Center took place. This building had been under construction for most of the year, and was completed at a cost of \$137,680. Built to accommodate more than 600 students and the faculty for lunch in the big hall, it is proving of great usefulness. It also has a large faculty room and a common room where meetings and smaller gatherings can be held.

Graduation was held on June 5. Of the 88 students who graduated, 87 are continuing their education in universities on the mainland and at the University of Hawaii. One member of the graduating class was admitted to the Naval Academy. Five students won scholarships, as follows: Royce Fukunaga, Stanford; Dennis Ing, John Hopkins; Edmund Whang, Harvard; Robert Nako, Purdue; and Roy Adaniya, Columbia. Three others who were semi-finalists in the National Merit Scholarship Contest, Ronald Murata, Cedric Takamoto, and Earl Lau, are attending the University of California.

### REPORT OF THE HAWAII PREPARATORY ACADEMY

The Academy is having an interesting, if somewhat difficult year. By extending our opening date to the last possible moral and practical deadline - almost the very end of September - we were able to move into our new dormitories even though they were not yet completed and we had to crowd three and four boys into rooms intended for two. It was a good thing that the dormitories were far enough along to be used even in this difficult way as there were absolutely no facilities other than these in which to house our largest boarding enrollment in the school's history. The old dormitories, which I had sworn anyway be never again used to house boys, had already been converted into classrooms and other facilities. Had anything happened to prevent the new buildings from being usable, the families of 128 boys would have been searching frantically, not to say desperately, for schools for their sons! All of us - families and school alike - breathed heartfelt sighs of relief. Judging from the wild rumors which I understand abounded in Honolulu, the parents' sigh was probably even deeper than our own. We at least knew that the buildings were moving along with reasonable hopes of being finished.

Anyway, everything turned out all right! And in six weeks or so we were able to end the crowding and place each boy in his rightful room. Actually, boys who had spent the last years at the Academy in small sections of 12 to 15 boys in each didn't even know they were being crowded this Fall!

Today, then our boys are living in beautiful buildings with hills behind them and mountains on the horizon. The Dining Room and the Common Rooms all afford unforgettable views which cannot help but insinuate themselves into the students' beings. Also, some of the athletic fields down below on the flat portions are nearly ready. Right now, we operate between two campuses, doing all of our living and eating on the new site and holding all of our classes, laboratories, chapel and athletics on the old. By this Spring we hope that sports will be transferred to the new site.

Of course, the Administration and the faculty do not revel in the constant transporting back and forth by busses and cars. Most of the boys, however, appear to regard it as quite interesting and something of a break in normal routine! And we do have a wonderful new bus, largely thanks to the help of one of our boys' father, Mr Robert Maxey of Honolulu.

Needless to say, we are eager for the day when all of our activities are on one campus, and we are bending every resource toward accomplishing this achievement in record time. But I can truthfully admit that the buzzing back and forth between two campuses is less an irritant to me personally than was the horrible business of double shifts at meals which we had to undergo all last year, causing me to interrupt my duties and face temptation six times daily rather than the normal three!

I feel that our year is a notable one even with all the problems which our peculiar two-campus arrangement produces. We have taken a large step in our growth, having gone from 94 boarding students to 128 and increasing the size of the teaching faculty from 9 to 14. Increasing day student enrollment, also, gives us a student body of close to 170. As new dormitories will not be available by Fall and as the temporary Dining Room and the busses are at the stretched point, it is my earnest - indeed, facilities make it a requirement - hope to hold next year's enrollment at the present figure and retrench our position.

The year has gone very well so far and has had a few heartening developments, including the formation of what promises to be a very good choir and glee club and the right man to lead it. Our tiny graduating class of 13 students is distinguished by having in its ranks two semi-finalists in the Merit Scholarships and one other who received the Merit Letter of Commendation. Two or three others are distinguishing themselves scholastically in other ways. As usual, of course, all of our juniors and seniors take the College Board Examinations and other tests. The students coming up from the lower ranks look very good, too.

Admissions are presently our knottiest problem to date in the school's history. There are many, many more applications than there will be places; and, though we prefer this situation to its opposite, we are going to have to search for the wisdom of Solomon when it comes to making the final decisions.

Our new Mother's Association has proved and continues to prove itself a most significant force and is being of tremendous help in many ways. We are again deeply indebted to the women of the Episcopal Church' all over the country for the help

they are giving us toward furnishing housekeeping needs in the new buildings.

#### DIOCESAN HOUSE - ARMY AND NAVY SERVICE CENTER

Though the activities at the Diocesan House and Service Center are quite the same, new faces are constantly appearing. Several thousand young men from all branches of the service have stayed at the Center from one to thirty days. We always have among these young men those who help at the Cathedral as Sunday School teachers, Acolytes, etc. Some have become interested in the ministry through the contacts made with the Cathedral.

We have had some weddings for our young men, and have let them use the Center for their receptions. Some of the romances have had their inception as the result of friendships they have made at the Center and Cathedral.

One guest room has been occupied by Church workers while they have been waiting to occupy their apartment or home. Several clergy have been with us while in transit.

The Diocesan Altar Guild meets weekly at the Diocesan House, as do the Girl Scouts. Members of the Philippine Independent Church have met in the Diocesan House on several occasions. They had two dinners for their congregation and a surprise birthday party for their minister. The Executive Board of the Churchwomen in Hawaii holds meetings in the Diocesan House, as do other Diocesan Committees. The Board of Directors holds luncheon meetings here. Entrance examinations for prospective students for the Hawaii Preparatory Academy are taken at the House.

Many of the service personnel are given storage space for their clothing while they are on maneuvers or at the base. Provision is also made for them to keep supplies so that they may cook their own meals. This is a great diversion for them. Many a young man has learned the art of cooking in our kitchen.

A gift of a large TV was the best thing that has happened to us for some time. The young men on leave watch the programs with great interest. Weekends find the living room filled with interested spectators.

The Hostess received many letters and pictures at Christmas from former guests, telling of their school work, their weddings, or sending pictures of their children, which was a very rewarding experience.

#### THE DIOCESAN HOSTEL

The Diocesan Hostel, above the offices of the Bishop, is in almost constant use. Missionary and visiting families and clergy from other islands frequent the Hostel. Families going to the Pacific to work for the Church are sent to us by National Council.

These apartments fill a great need in the Diocese when hospitality is needed by many transient Church families going through our Islands. Each apartment has a living room, kitchen and bathroom. There are two extension beds in each apartment, which will take care of four in an apartment, if necessary. Baby cribs are provided when needed.

The numerous requests from our Overseas Department of National Council, bishops and clergy have exceeded our ability sometimes to provide hospitality. We do the best we can with limited facilities.

#### CANTERBURY HOUSE

Early in 1959 the building which had been Canterbury House was torn down, and a new Canterbury House was built with funds from the UTO and the National Council. The new building, dedicated in May, is far more adequate for the uses for which a Canterbury House is needed than was the old building. There are a lounge, a permanent small chapel, a kitchen, an office, a workroom and bathrooms.

The program at Canterbury necessarily suffered during the second semester because of the inadequate facilities during the building program.

For the first time Canterbury House was kept open during the Summer Session, and although perhaps only 15 students were involved during this time, I feel it was a successful initial summer program. For the Church to maintain contact with at least this many during that short time is far better than for it to have no contact with any at all.

This school year so far we have followed much the same program as in past years. Canterbury House is open each day from 7:45 A M to 4:30 P M. It provides a place for students to gather between classes at the University. Twice each week there are celebrations of the Holy Communion. Twice each month on Friday evenings meetings are held with occasional speakers or other programs. At various times the group as a whole undertakes some service project, the first one for this year being one to aid the Christmas Seal drive. At Christmas Canterbury went caroling to a number of private homes and to two hospitals in the city. This year two Bible study groups in conjunction with the Wesley Foundation (Methodist) have also been held.

The program at Canterbury House for the past years and up to this very moment seems to have been, and to be, a program concerned with quantity rather than quality. Possibly the only future which can be justified for Canterbury House is one which will emphasize quality of program and quality of student. We have made little demands on students knowing that real demands will seriously curtail the number of students who use Canterbury House. But it would seem that a Christian organization at a university has the duty laid upon it to make demands: demands of time, demands of financial support, demands of commitment, demands of Christian conduct, demands of serious thought.

1959 ANNUAL REPORT  
DIOCESAN DEPARTMENT OF CHRISTIAN EDUCATION  
FOR 1960 ANNUAL CONVOCATION

The Department of Christian Education for the Diocese had a considerably active year in 1959, meeting a total of five times, and carrying on a rather heavy amount of correspondence with the National Department in Greenwich, Connecticut. A synopsis of its activities in chronological order for the year is submitted as follows:

1.) Following a detailed analysis submitted by individual clergy of their needs and concerns in the field of Christian Education, the Department engaged a member of National Council's Department of Christian Education to visit the Islands and conduct a conference and series of workshops and meetings with clergy and teachers. The Rev J Norman Hall was with us for two weeks spending a week with the clergy on Oahu, and two days each with the clergy and teachers of Maui, Hawaii and Kauai. The recommendation of the Department is that in future years we continue to engage representatives from National Council in this field, to keep us abreast of current thought, and to stimulate and further our programs of Christian Education at all age levels.

2.) In conjunction with the Honolulu Council of Church's Department of Christian Education, a Vacation Bible School Conference was held at the Church of the Holy Nativity in May for the purpose of encouraging and assisting churches in promoting summer instruction in Christian Education. It was a success and over 300 representatives from churches all over the island were in attendance.

3.) The Department sponsored the Annual Sunday School Cathedral Pilgrimage on Whitsunday, at which time Sunday School children from the Island of Oahu massed together for a Birthday Service and announcement of the final tally of the Mite Box Offering. Bishop Kennedy addressed the children and following the service refreshments were served at an informal reception for children and their teachers.

4.) Summer found a new beneficiary for the Birthday Thank Offering and distribution of pamphlets, cards and envelopes was undertaken along with promoting the needs of Internados in Mexico.

5.) National Council announced its new "Advance Adult Education" Program and the Department in conjunction with the Diocesan offices has arranged for the Rev Dr William Poteat of the Seminary of the Southwest to conduct a Clergy Conference on "Theology and Education" September 12-16, 1960. It is anticipated that this will give local stimulus for furthering Christian Education at the adult laymen's level.

6.) In the month of September, immediately following the Annual Clergy Conference at Mokuleia, the Department joined the Department of Christian Social Relations in sponsoring a Family Life Study Conference for laymen. Delegates from all Islands attended, and personnel from both Departments are available for promoting further study programs at the individual church level.

7.) During October the Department assisted the Council of Churches Conference on "Creative Expression in Christian Education" conducted at St Andrew's Cathedral attended by teachers and clergy from all over the island. Although relatively few of our own churches participated, it was well received and provided for Sunday School teachers and clergy many helps in terms of techniques and methods for their own programs.

8.) Late in the fall, after considerable effort and communication carried on over a number of years, Church School Missionary Offering Materials to be used in either the Epiphany or Lenten Season of 1960 arrived for distribution at Diocesan Headquarters. With adequate promotion by teachers and clergy alike, it is the Department's earnest hope that we may make the Church School Missionary Offering study in the year 1960 a meaningful one to young and old alike in all of our churches.

We are also working toward the ultimate goal of having full-time resident Chaplains in all of the major hospitals and institutions. We are happy to report that the Rev Seido Ogawa, a Congregational Minister, has just been appointed full-time Chaplain at the State Hospital in Kaneohe. The Rev Theodore Chinen continues as Chaplain at Oahu Prison.

The ministry of Health and Welfare is also carried on by regular services of Spiritual Healing at St Clement's and St George's.

#### REPORT OF THE DEPARTMENT OF PROMOTION AND PUBLICITY

The Department wishes to express its great appreciation to the local newspapers for their cooperation in giving coverage and prominence to the news items submitted to them during the course of the year. We particularly commend Mrs Harriet Gee, Church Editor for the Honolulu Star Bulletin for her interest and excellent coverage.

We appreciate the publicity extended to our District through the medium of Episcopal Church publications, The Living Church, Forth Magazine, the Witness and many publications of other dioceses and districts.

One of our outstanding means of placing the Church before the public is the radio broadcast of the eleven o'clock service at St Andrew's Cathedral. These broadcasts have been heard throughout the islands of the Pacific.

With the coming of Statehood, many requests have come to the Diocesan Office for more information concerning the Church in Hawaii. At the request of many Mainland dioceses and parishes, we have supplied them with Hawaiian, Okinawan, and Taiwan gifts for their local bazaars to promote missionary interest.

Our Church has been placed before the public eye in Hawaii through the television program each Sunday in "Pastor Up Front", sponsored by the Honolulu Council of Churches. Our clergy have appeared regularly and have done a commendable job in their panel discussions.

The Bishop appointed Mrs Zaida Male, of Holst and Male, Inc, in Honolulu, to represent our Church in Hawaii as Chairman of the National Church's Radio and Television Department. The Presiding Bishop's Christmas Message was broadcast in Hawaii through her efforts. She sends articles to "Script" and takes care of radio and television programs released from the Promotion Department.

The HAWAIIAN CHURCH CHRONICLE is the only monthly Diocesan publication. It is a means for getting the program of the Diocese into the hands of our people. We would stress the practice of many of our parishes and missions of providing a subscription for every family and individual who support the Church's budget. Our mailing list is 2700. Appreciation is extended to Mrs Aaron, and the girls of St Andrew's Priory, who assist in the mailing of these, and to Mr and Mrs Susumu Morita for addressing the envelopes each month.

Four attractive Diocesan leaflets for Sunday bulletins were designed by the Diocesan Office and printed for use in our churches or elsewhere. They are the

seal of the Diocese, the Diocesan Cross, the Episcopal Church seal and the pictures of those bishops and royalty who had an historical part in founding the Diocese. They are all beautifully colored and are available in the Diocesan Office at a very nominal cost.

The one constant plea for the Chronicle is more interesting news and pictures from our congregations. These items should be in the Diocesan Office before the 15th of each month.

A weekly notice of services in all of our churches on Oahu appears as a paid advertisement each Sunday in our two daily newspapers.

Large advertisements of our Church appeared in the Statehood and New Year's editions of our Honolulu papers.

#### REPORT OF LAYMEN'S LEAGUE OF THE EPISCOPAL CHURCH IN HAWAII - 1959

The first event on our calendar was the corporate communion and breakfast held February 22, Washington's Birthday. Some 180 men attended and the special collection netted \$970.00. This collection is earmarked for the upkeep of our recreation center at Mokuleia. Three services were held on Oahu.

1. St Andrew's Cathedral
2. St Christopher's, Kailua
3. St Stephen's, Wahiawa

Second, six churches provided transportation each Sunday in March for servicemen wishing to attend church services.

In May, your chairman attended the conference of the 8th Province held in Healdsburg, California. The Rev William Grosh attended this conference as the clergy delegate.

In June, Dr Howard Harper visited Hawaii en route to Australia. A luncheon was held, attended by 10 key laymen as a discussion group. The same evening a dinner was held for Dr Harper, attended by the keymen of the Island and their guests, at Holy Nativity's Youth Center.

A 3 day training conference was held September 11, 12 and 13 at Mokuleia, attended for the first time by delegates of men's, women's and youth groups. 85 lay people were there as well as a number of clergy. The program was conducted by The Rev Mr Grosh and your chairman and was very enthusiastically received.

In November, we organized a Quiet Half Day at the Cathedral under Bishop Kennedy. It is hoped this can become an annual affair as great satisfaction was expressed by the 500 men who attended.

At this same time we solicited the aid of the clergy in instituting a program of Reclaiming the Lapsed. This, perhaps, lacked some impetus due to Christmas but is still in progress.

ANNUAL REPORT FOR 1959 OF THE DEPARTMENT OF YOUTH

The Youth of the district started 1959 with the House of Young Churchmen and Junior Episcopal Churchmen of Hawaii Annual Convocation banquets when they heard the Very Rev John C Leffler, Dean of St Mark's Cathedral, Seattle, Washington. Miss Maile Crooker was elected HYC president.

The Department sponsored five camping sessions at Mokuleia, Oahu, four camping sessions at Camp Pecusa, Maui and one camping session at Hapuna Beach, Hawaii, with the largest enrollment ever achieved in the district.

The Jecoh Conference was held in July at Mokuleia under the direction of their advisor, The Rev Edwin Bonsey. The HYC went to Camp Pecusa, Maui in August for the most successful conference held in recent years with 85 registered. Special chartered planes transported the Oahu delegation. Subject matter for the Conference was the Lambeth Report on the Christian Family. T V station KM of Maui and the Kahului R R made a telecast broadcast of the conference.

The first annual formal Bishop's Ball, honoring Bishop and Mrs Kennedy was held at the Royal Hawaiian Hotel in June with 156 couples present. The EYC Council of Oahu planned the successful affair.

Under the auspices of the EYC Council of Oahu Episcopal Youth, the young people gave leadership for recreational programs for Hawaii's Mentally Retarded Children, as their social service project.

The HYC Council in planning the youth work strongly advocated the use of the National Churches "Episcopal Young Churchmen's Handbook" for program planning.

Bishop Kennedy, Clergy, Delegates and Friends:

The Balance Sheet and supporting schedules which were mailed to the delegates and clergy reflect the financial position of the Diocese as of December 31, 1959.

On Schedule One (1) you will note that the investments in our Diocesan Trust Investment Fund, while carried at a cost value of a little over \$680,000. . . had a market value, at the end of the year, of over one million one hundred thousand dollars.

During the year we received from National Council in regular appropriations for salaries and operating, \$97,661. This is almost ten thousand dollars less than the previous year.

Although most of the parishes and missions participated in projects outside the Diocese, such as the Good Friday Offering, Birthday Thank Offering, the Presiding Bishop's Fund, and so forth, there are still some who do not encourage and promote such programs.

All assessments and quotas were paid in full for the year. One mission in the Islands paid \$40 more than its assigned assessment; the missions on Okinawa overpaid \$670.

At the end of the year, our indebtedness to banks and National Council totaled \$630,420. . . an increase of \$63,265, over the same period the year before. Re-payments for the year totaled \$210,288, while new obligations amounted to \$273,550. I am happy to be able to report that all payments have been made when due, not only on loans but for the general operation of the Diocese.

Assessments and Quotas for 1960, calculated in accordance with our approved formula, have increased \$6,615, and our Diocesan Budget has increased accordingly. There are still areas wherein we turn to National Council for aid when it should be the responsibility of the Diocese. The salary of the Treasurer is a good example.

As a member of the Eighth Province, we are obligated to participate in the Capital Funds Campaign being conducted by the Church Divinity School of the Pacific. While it is far below our assigned assessment, we have set our goal at \$50,000, to be raised over a period of three years.

Our National Church assessment remains at \$8,000 for 1960. This figure is included in our Diocesan Budget of \$60,300. In closing I want to make a motion that this Convocation approve the proposed Diocesan Budget as submitted.

Gentlemen:

We have examined the balance sheet of The Protestant Episcopal Church in the Hawaiian Islands, as of December 31, 1959. Our examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as we considered necessary in the circumstances.

The accounts and records of the church do not reflect the financial position and results of operations of parishes, missions, and institutions which conduct the activities of the Protestant Episcopal Church throughout the Territory of Hawaii. However, certain trusts of these departments are held by the church, and accordingly have been taken into account in the accompanying financial statements.

Inasmuch as title to all real property, except the real property of Iolani School and St Clement's Church, is vested in The Protestant Episcopal Church in the Hawaiian Islands, this property is accounted for in the records of the church. However, the carrying value of the real property is not infrequently an estimated amount, not readily subject to accurate determination, intended to represent expenditures made not only by the church but also by missions, parishes and other persons, or, more recently, an amount which represents only those expenditures made from the proceeds of loans from church funds or lending institutions which do not include certain other expenditures made through the treasurer's office or directly by churches and parishes.

In our opinion, the accompanying balance sheet and supporting schedules have been prepared in accordance with established accounting practices of The Protestant Episcopal Church in the Hawaiian Islands on a basis consistent with that of the preceding year.
